FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 22nd day of March, 2004, C. Marshall Bennett, an unmarried man, executed that certain mortgage on real property hereinafter described to Heritage Bank, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument No. 20040402000169400, said mortgage having subsequently been transferred and assigned to Wells Fargo Bank, N.A., by instrument recorded in Instrument Number 200908000301380, in the aforesaid Probate Office ("Transferee"); and

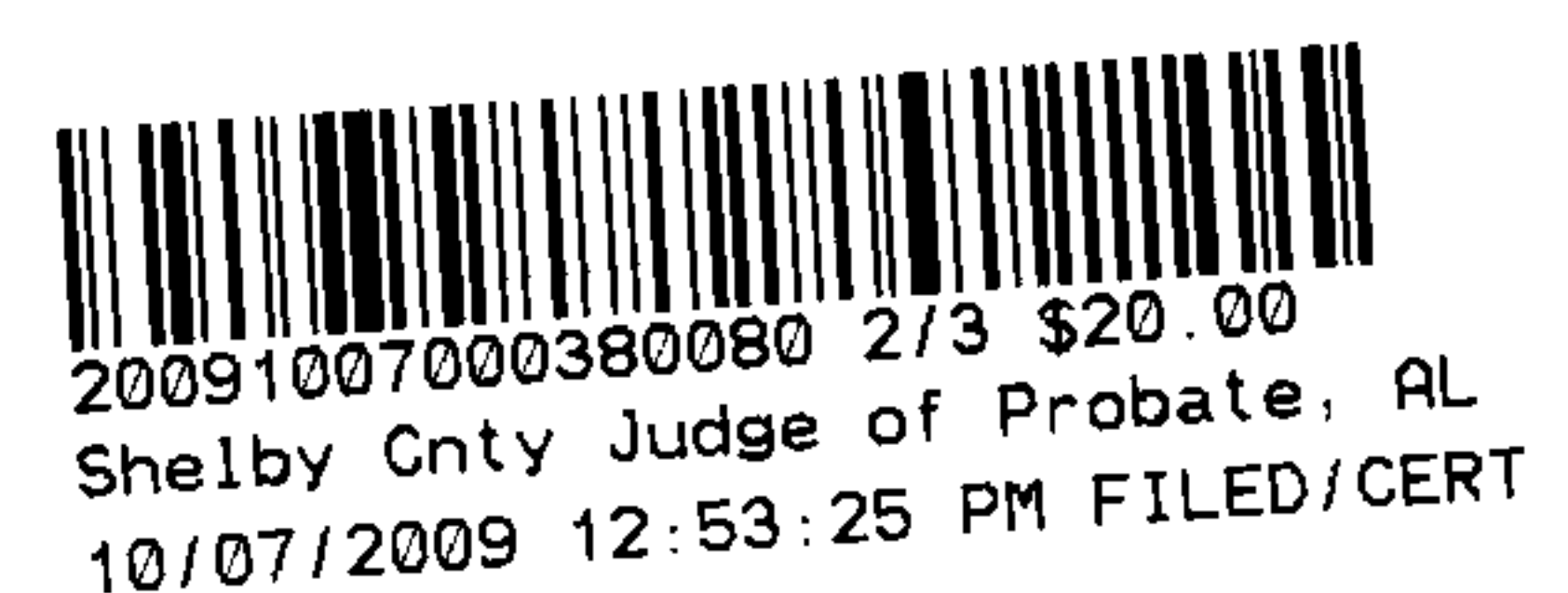




