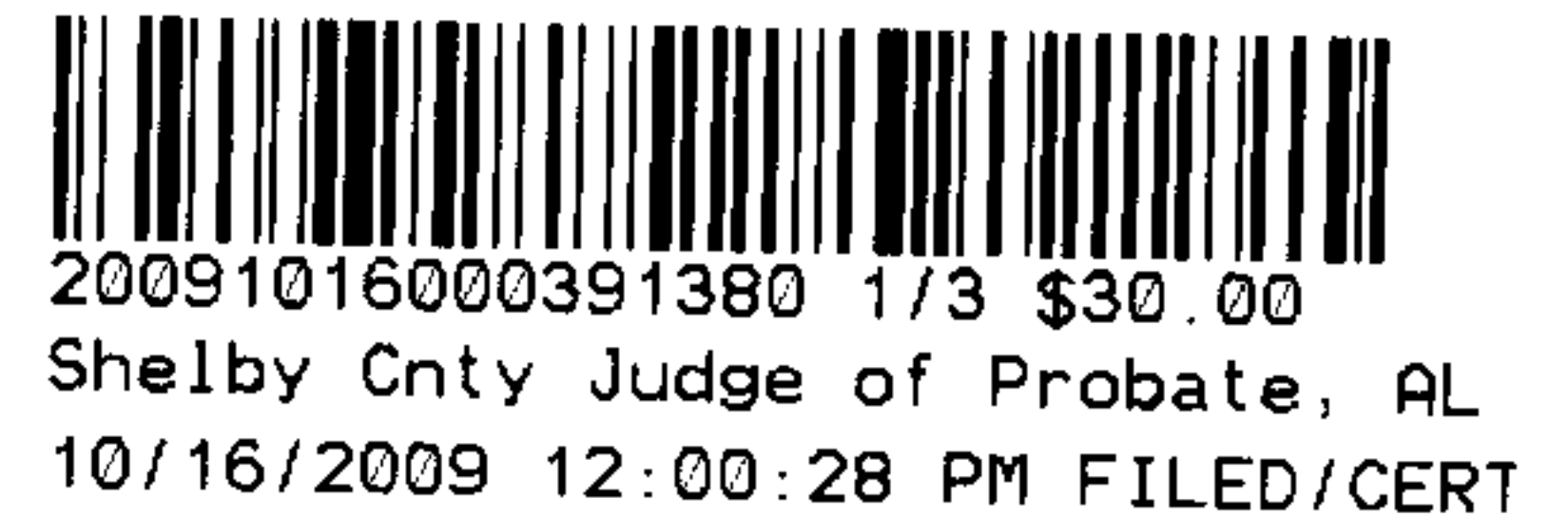


**RESTATED**  
**ARTICLES OF INCORPORATION**  
**KIDS FIRST AWARENESS COALITION PROGRAM**

I, the undersigned natural person of age, nineteen years of age or more, acting as the organizer of a non-profit corporation under the Alabama Non-Profit Corporation Act, hereby adopt the following Articles of Incorporation for the Non-Profit Corporation:



**ARTICLE ONE**

The name of the Non-Profit Corporation has changed from:  
Kids First Awareness Coalition Program to  
Kids First Awareness Community Learning Center

**ARTICLE TWO**

The address of the principal place of business of the Non-Profit Corporation is:

**ARTICLE THREE**

The period of duration of the Non-Profit Corporation shall be perpetual from its effective date.

**ARTICLE FOUR**

**ARTICLE FIVE**

Under the Code of the State of Alabama Section 10-3A-26, a corporation may have one or more classes of members or may have no members. If the corporation has one or more members, the designation of such a class or classes, the manner of election or appointment and the qualification and rights of the members of each class shall be set forth in the articles of incorporation or the bylaws. There shall be three board members for purpose of management and finance. The initial members of the board will be:

M. Cindy Hawkins, the primary operator of the organization, Alabaster, Al.  
Oscar Hawkins, Alabaster, Al.  
Bonnie Dawson, CPA, 134 Grandview Circle, Maylene, Al. 35114

The member(s) of the Non-Profit Corporation shall have all the right to admit additional members, but only upon unanimous vote of all the currently existing member(s). New members may be admitted upon any terms and condition as the current members(s) may agree upon by unanimous vote.

## ARTICLE SIX

The Non-Profit Corporation is organized exclusively for raising funds for Kids First Awareness Program Community Learning Center a Non-Profit charitable, religious, educational, community outreach and/or scientific purposed under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

## ARTICLE SEVEN

The Non-Profit Corporation shall end upon only the decision of the board of directors. Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposed within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a pubic purpose. Any such assets not disposed of by the Common Pleas Court of the county in which the principal office of the organization is then located, exclusively for such purpose or to such organizations(s), as said court shall determine which organized and operated exclusively for such purpose.

## ARTICLE EIGHT

The date of organization is the 14<sup>th</sup> day of January 2003, as verified by the Judge of Probate of Shelby County.



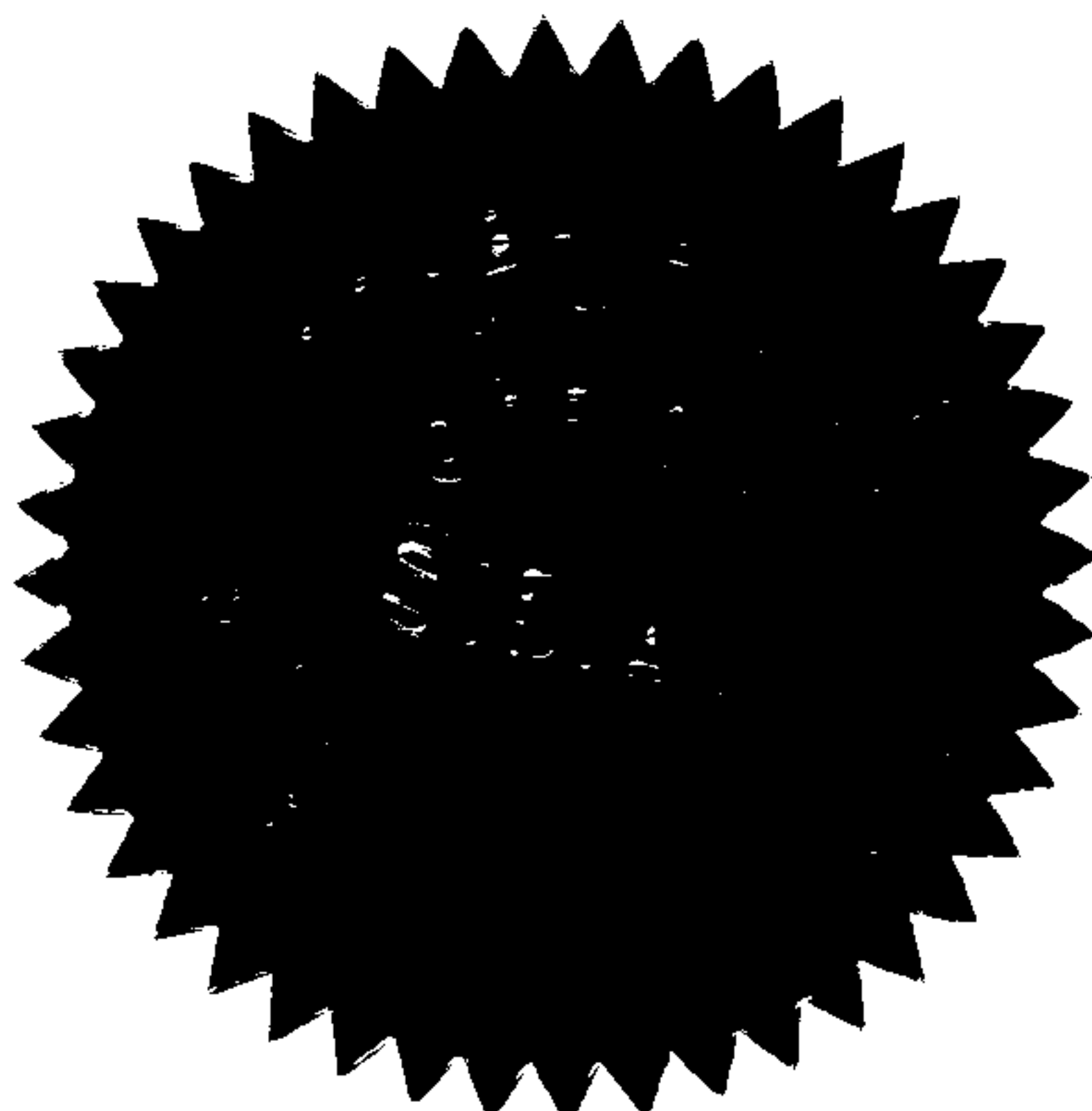
## Certificate of Incorporation Restated and Amended Of KIDS FIRST AWARENESS COMMUNITY LEARNING CENTER


