PLEASE TAKE NOTICE that on this date the undersigned counsel for Ferris & Schoeman, LLC d/b/a Kiliwarrior Expeditions ("Kiliwarrior Expeditions"), pursuant to ALA. CODE §§ 6-9-232 and 6-9-233, has filed the following for the purpose of transferring and collecting on a foreign judgment obtained against Ms. Dana Colluci ("Ms. Colluci"), who is a resident of Jefferson County, Alabama and over the age of nineteen (19) years:

1. A certified copy of the Final Order entered on August 5, 2009, by the Circuit Court for Botetourt County, Virginia, by which a default judgment was

entered against Ms. Colluci and in favor of Kiliwarrior Expeditions in the civil action in that Court styled Ferris & Schoeman, LLC d/b/a Kiliwarrior Expeditions v. Dana Colluci, Case No. CL09-461 (referred to hereinafter as the "Judgment"). The Judgment further awarded to Kiliwarrior Expeditions from Ms. Colluci the monetary sum of \$21,995.00, plus interest at the rate of 6% from December 18, 2008, and court costs of \$112.00. (The certified copy of the Judgment is attached hereto as Exhibit A and incorporated herein by reference.)

2. An Affidavit of Isak J. Howell, Esq., one of the attorneys for Kiliwarrior Expeditions, which is attached hereto as Exhibit B and incorporated herein by reference. In the Affidavit, Mr. Howell testified, among other things, that Ms. Colluci is a resident of Jefferson County, Alabama and the Judgment is valid, enforceable, and remains unsatisfied.

WHEREFORE, based on the foregoing and in accordance with Alabama's Uniform Enforcement of Foreign Judgments Act, Ala. FINAL ORDER

CAME TODAY the Plaintiff, Ferris & Schoeman, LLC d/b/a Kiliwarrior Expeditions ("Kiliwarrior"), by counsel, on its Motion for Default Judgment filed pursuant to Rule 3:19 of the Rules of the Supreme Court of Virginia against Defendant, Dana Colluci.

Based on the allegations set forth in the Motion for Default Judgment, the pleadings on file, and it otherwise appearing proper, the Court finds that Dana Colluci was properly served with the Summons and Complaint in this matter and that, pursuant to the law of Virginia, her deadline to respond to the Complaint was July 8, 2009, and that she failed to respond within the time permitted by law.

Accordingly, it is hereby ORDERED that Dana Colluci is in default and the Plaintiffs

Motion for Default Judgment against Dana Colluci is hereby GRANTED.

The Court further ORDERS that Ferris & Schoeman, LLC d/b/a Kiliwarrior Expeditions shall recover from Defendant, Dana Colluci, the sum of \$21,995.00, plus interest at the rate of 6% from December 18, 2008, and \$112.00 as the costs of this proceeding.

AFFÍDAVIT OF ISAK J. HOWELL

I, Isak J. Howell, hereby state that the following facts are true and accurate based upon my own personal knowledge:

- 1. My name is Isak J. Howell. I am over the age of nineteen (19) years.
- 2. I am licensed to practice law in the Commonwealth of Virginia. I am an attorney with the law firm of Woods Rogers PLC, in Roanoke, Virginia.
- 3. My law firm was hired by Ferris & Schoeman, LLC, d/b/a Kiliwarrior Expeditions ("Kiliwarrior Expeditions") to pursue legal action against Dana Colluci for a claim of breach of contract. That action was filed in the Botetourt County Circuit Court and was styled Ferris & Schoeman, LLC d/b/a Kiliwarrior Expeditions v. Dana Colluci, Case number CL09-461 (hereinafter, the "Lawsuit").
- 4. On August 5, 2009, a default Judgment was obtained by Kiliwarrior Expeditions in the Lawsuit against Ms. Colluci in the amount of \$21,995.00, plus interest at the rate of 6% from December 18, 2008 and \$112.00 in costs. The time for Ms. Colluci to file an appeal of this Judgment expired on September 4, 2009, without her having filed an appeal or otherwise having filed any post-judgment motion.


