Whereas, on the 4th day of April, 2005, a decree was rendered by the Probate Court of said county for the sale of the lands, hereinafter described, and conveyed for the state and county taxes then due from **Sybil Odessa White & John W. 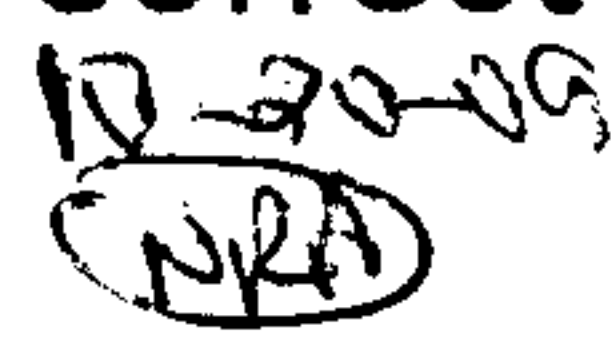
