ARTICLE I

Name

The name of this corporation shall be Hope for Gabe, Inc.

ARTICLE II

Place of Business and Address

The principal office of Hope for Gabe, Inc. ("Hope for Gabe") in the State of Alabama shall be located in the City of Birmingham, County of Shelby, Alabama. The Corporation may have such other offices, either within or without the State of Alabama, as the Board of Directors may designate or as the corporation may require from time to time.

ARTICLE II

Duration


The duration of the corporation is perpetual, unless otherwise stated.

ARTICLE III

Purpose

Section 1. This corporation shall be operated exclusively as a charitable, religious, educational, and scientific purposes under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, within the State of Alabama as so deemed appropriate for the corporations by its Board of Directors and to perform all acts necessary and proper to carry on such activities.

Section 2. This corporation shall observe and adhere to all local, state and federal laws pertaining to non-profit corporation as defined in section 501(c)(3) of the Internal Revenue Service Code and Chapter 10-3A, of the Alabama Code.






