





C. Reservation By Grantor.

Notwithstanding anything contained in this Conveyance to the contrary, Grantor does hereby expressly except from this conveyance and reserve unto itself, its successors and assigns, the facilities constituting its 230 kV electric transmission line commonly referred to as the "Yellowdirt" line (but excluding any that comprise an integral part of the Gaston-Goat Rock Transmission Line # 1), which is located upon the same structures as the Gaston-Goat Rock 230 kV Transmission Line # 1 from its beginning at Grantor's E.C. 

D. Miscellaneous.

Notwithstanding anything contained herein to the contrary, the buildings, other structures and improvements, fixtures and real and personal property herein conveyed are hereby conveyed by Grantor to Grantee, and acquired by Grantee, upon an "as is" and "where is" basis. Neither Grantor nor any person or entity of any kind or nature whatsoever acting for or on behalf of Grantor either has made or hereby makes any representation or warranty whatsoever with respect thereto, whether express or implied, including, without limitation, any representation or warranty as to the value, quality, condition, salability, obsolescence, merchantability, fitness or suitability for use thereof. Notwithstanding the foregoing, Grantee shall, together with Grantor, have the benefit of and is hereby assigned all manufacturers' and vendors' warranties and all patent, trademark and service mark rights running to Grantor in connection with the property herein conveyed to the extent the same are assignable by Grantor. To the extent that the conveyance of any right of Grantor hereunder may require the consent of any other party, the same shall be deemed not to be conveyed until such consent is obtained. The rights and other property conveyed hereby are conveyed subject to all matters of record in the respective Counties listed above and to all matters that an accurate survey of the Easement Area would disclose.

Grantee specifically agrees and hereby waives, releases, and discharges any claim (statutory, contractual or otherwise) it has, or may have in the future, against Grantor with respect to or arising out of the past, present or future conditions or compliance or noncompliance of the Transmission Lines in regard to any environmental laws, rules, regulations, order or requirements (including, without limitation, the Comprehensive Environmental Response, Compensation and Liability Act, as amended, 42 U.S.C. §§ 9601

Depiction of SEGCO Strip







