KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 20th day of June, 2006, Eric A. Childers, a single man and Kimberly K. Metcalf, a single woman, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc. acting solely as nominee for Superior Bank, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20060628000310930, said mortgage having subsequently been transferred and assigned to Wells Fargo Bank, N.A., in the aforesaid Probate Office ("Transferee"); and

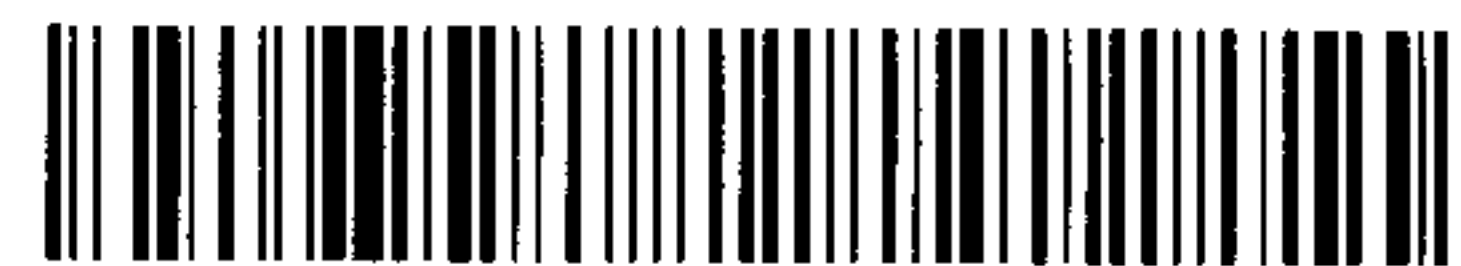
