

## ARTICLES OF ORGANIZATION OF SICARD HOLLOW PROPERTIES, LLC

## TO THE JUDGE OF PROBATE SHELBY COUNTY, ALABAMA

The undersigned, desiring to form a limited liability company pursuant to the laws of the State of Alabama, certifies as follows:

- 1. <u>NAME</u>. The name of the limited liability company is Sicard Hollow Properties, LLC (the "Company").
- 2. <u>DURATION</u>. The existence of the Company shall commence on the date of the filing of these Articles of Organization in the Office of the Judge of Probate of Shelby County, Alabama, and its duration shall be perpetual; provided, however, that the Company shall be dissolved (a) upon the written consent of all of the members; (b) as provided in the Operating Agreement; or (c) as may be required by the Alabama Limited Liability Company Act.
- 3. <u>PURPOSE</u>. The purposes for which the Company is organized are to own real estate, and to engage in the transaction of any and all lawful business for which limited liability companies may be organized under the laws of the State of Alabama.
