Shelby County, Alabama, described as follows:

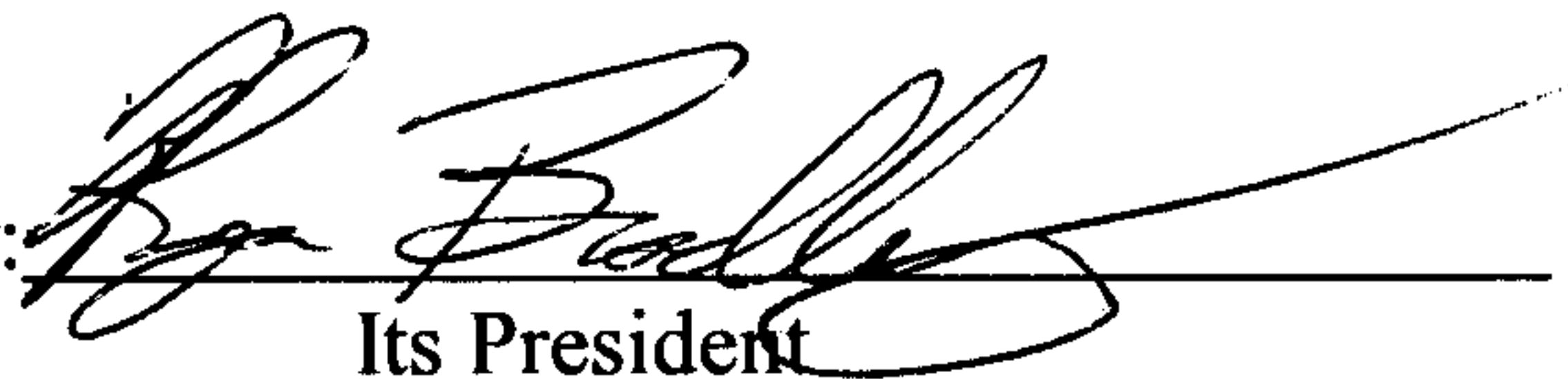

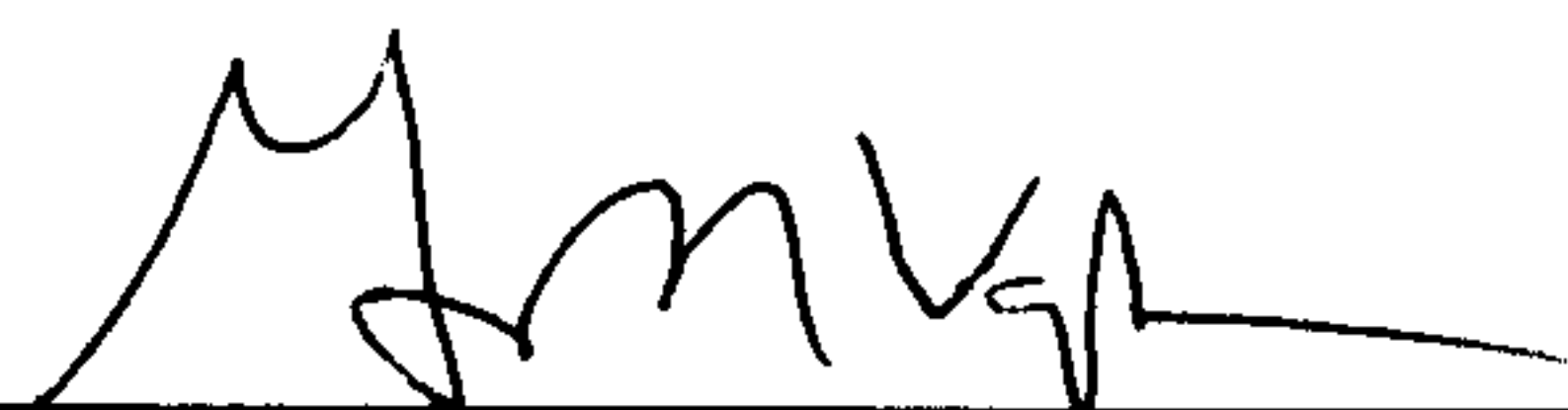
