Attached Legal Description

Commence at the intersection of the West line of the SE 1/4 of the NW 1/4 of Section 26, Township 19 South, Range 1 West, and the South right of way boundary of (old) Highway#280; thence Easterly along said right of way boundary, a distance of 30.00 feet, to the point of beginning; thence continue Easterly along said right of way, a distance of 140.00 feet; thence turn a deflection angle of 38 degrees 52 minutes 00 seconds to the right and proceed for a distance of 98.00 feet, thence turn a deflection angle of 24 degrees 54 minutes 00 seconds to the left, and proceed for a distance of 156.00 feet; thence turn a deflection angle of 84 degrees 28 minutes 30 seconds to the right and proceed for a distance of 77.25 feet; thence turn a deflection angle of 84 degrees 28 minutes 30 seconds to the right and proceed for a distance of 75.00 feet; thence turn a deflection angle of 95 degrees 31 minutes 30 seconds to the right and proceed for a distance of 97.25 feet, thence turn a deflection angle of 12 degrees 09 minutes 00 seconds to the right and proceed for a distance of 307.65 feet, to the point, of beginning.
