FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 28th day of March, 2005, Sylvia E. R. Wright, a single woman, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc. as nominee for Homesouth Mortgage Services, Inc. , which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number: 20050407000162660, said mortgage having subsequently been transferred and assigned to Everhome Mortgage Company, ("Transferee"); and
