KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 1st day of December, 2006, Dan Perez, a single man, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., solely as nominee for MortgageAmerica, Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Inst. # 20061212000604600, re-recorded in Inst. # 20070302000095980, said mortgage having subsequently been transferred and assigned to Chase Home Finance LLC, ("Transferee"); and
