That in consideration of **ONE HUNDRED THIRTY SIX THOUSAND TWO HUNDRED AND NO/100'S (\$136,200.00) DOLLARS** to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt whereof is acknowledged, We, **FRANKLIN T. PRITCHETT, A MARRIED MAN AND SHARON K. DANIEL, A MARRIED WOMAN** (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto **CARL D. JETT AND JESSICA B. JETT** (herein referred to as GRANTEEES, whether one or more), as joint tenants with right of survivorship, the following described real estate, situated in **SHELBY County, Alabama** to-wit:


**\$138, 924.00** of the consideration herein was derived from a mortgage loan closed simultaneously herewith.


