MEMORANDUM OF LEASE

This MEMORANDUM OF LEASE ("Memorandum") is executed on this 15th day of October, 2009, by and between SWF Birmingham, LLC, a Delaware limited liability company, acting through its authorized agent and property manager, Molpus Timberlands Management, LLC ("Lessor"), and Alabama Trust Fund for the State of Alabama (pursuant to Amendment 543 to the Alabama Constitution of 1901) ("Lessee").

1. Hunting, Fishing and Recreation Lease Agreement. Lessor and Lessee have entered into a Hunting, Fishing and Recreation Lease Agreement dated October 15, 2009 (the "Lease") pursuant to which Lessor has agreed to lease to Lessee (subject to the terms and matters set forth in the Lease) the sole and exclusive right to lawfully and non-commercially manage and use that certain property described on Exhibit "A" attached hereto ("Property") for public hunting, fishing and recreation, together with a non-exclusive right to ingress and egress over the Property for such purposes.
2. Term. The term of the Lease runs from the date of the Lease until September 30, 2102, unless earlier terminated pursuant to the Lease (the "Term").
3. Notice. This Memorandum has been executed and delivered by the parties for the purpose of recording and giving notice that a contractual relationship has been created between Lessor and Lessee regarding the use of the Property for public hunting, fishing and recreation, all in accordance with the terms, covenants and conditions of the Lease.
4. Conflicts. The terms and conditions of the Lease are incorporated by reference into this Memorandum as if set forth fully herein at length. Any conflict between this Memorandum and the Lease shall be resolved in favor of the applicable provision in the Lease.

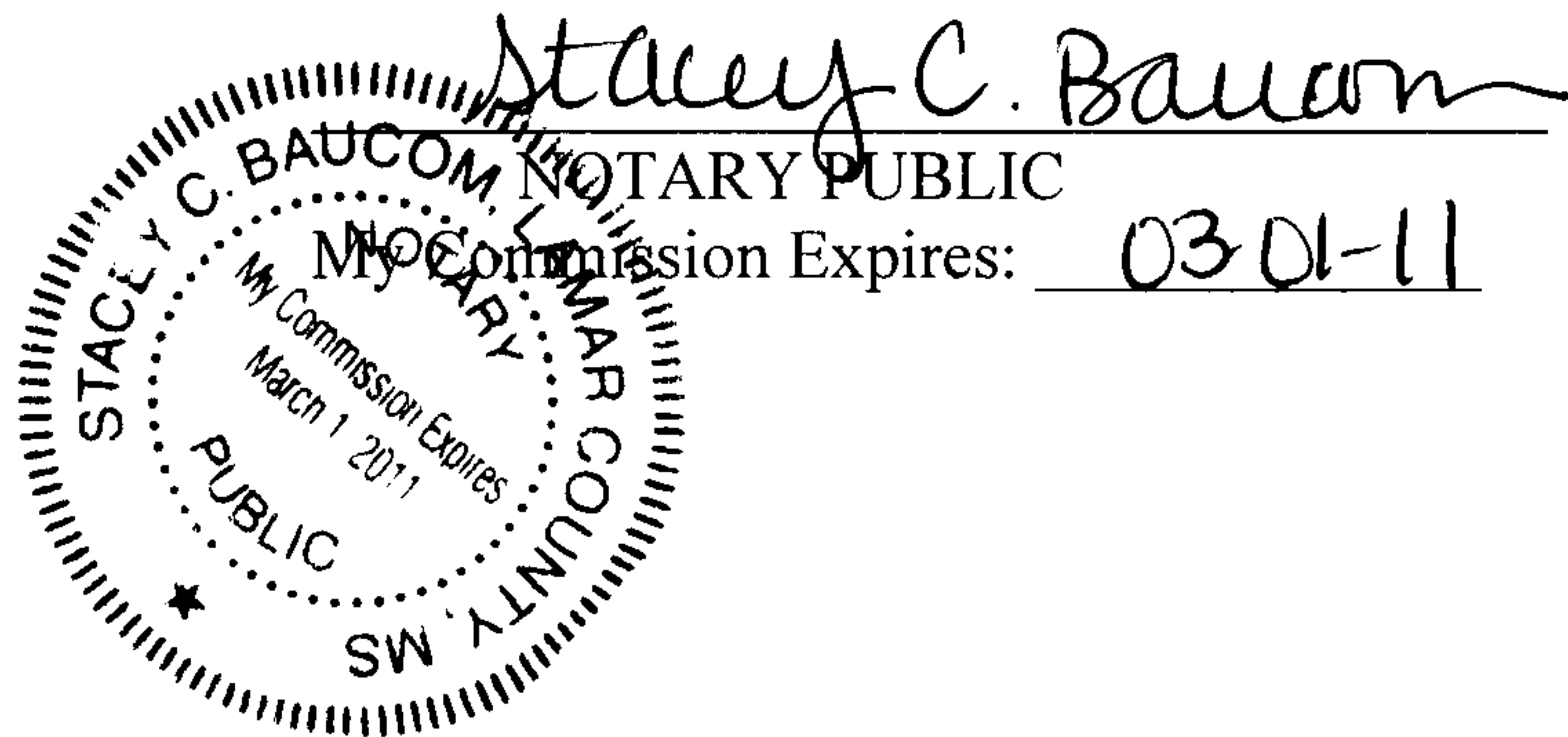

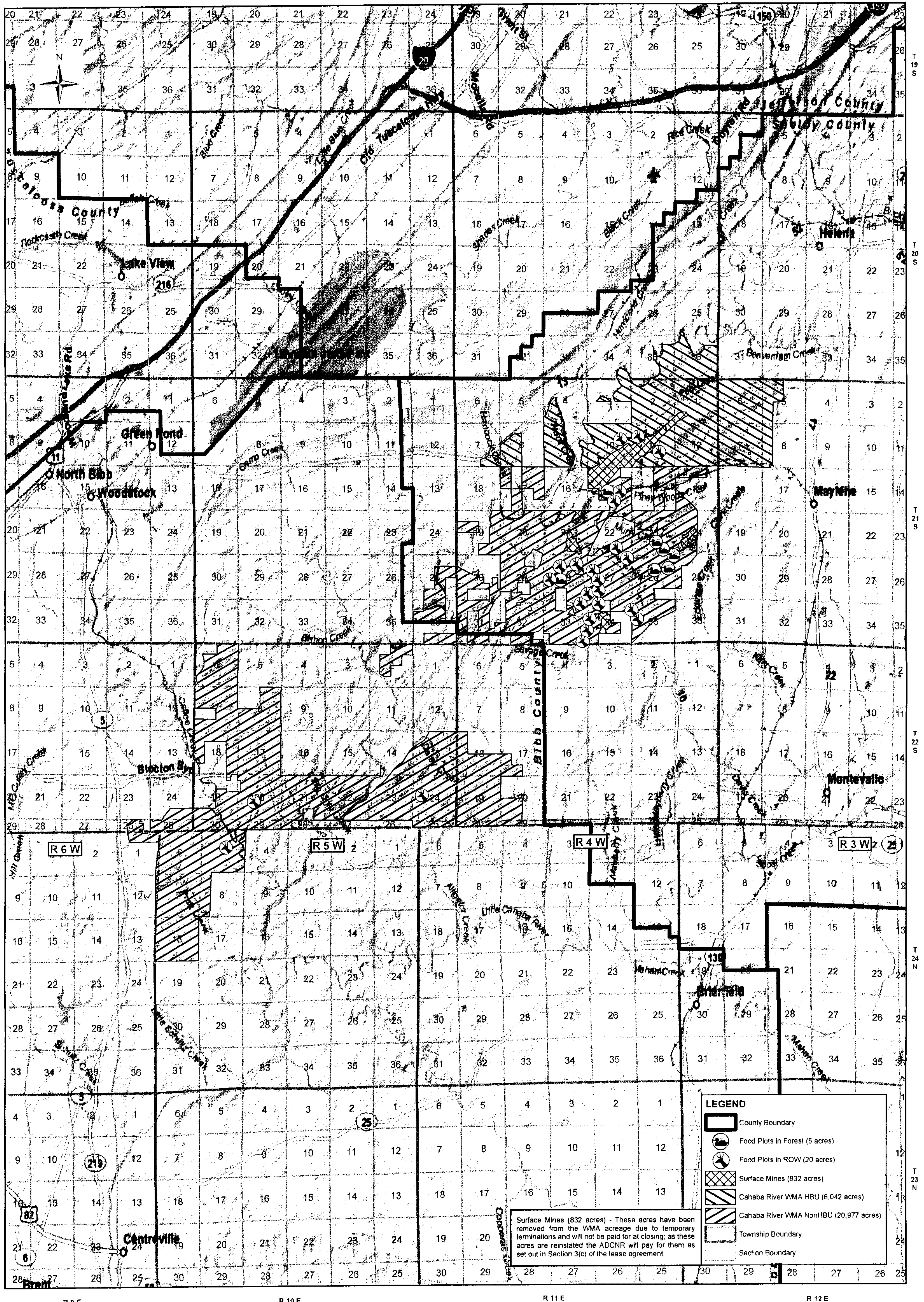
