KNOW ALL MEN BY THESE PRESENTS, That:

WHEREAS, heretofore on April 11, 2003, **Rene Joseph Messier, III and Amber Leigh Cook, both unmarried persons, Party of the First Part**, executed a certain mortgage to **Mortgage Electronic Registration Systems Inc., acting solely as nominee for GMAC Mortgage Corporation its successors and assigns**, which said mortgage is recorded in Instrument No. 20030415000229590, in the Office of the Judge of Probate of Shelby County, Alabama Which said Mortgage was last sold, assigned and transferred to Nationstar Mortgage LLC; and 20091119000431770

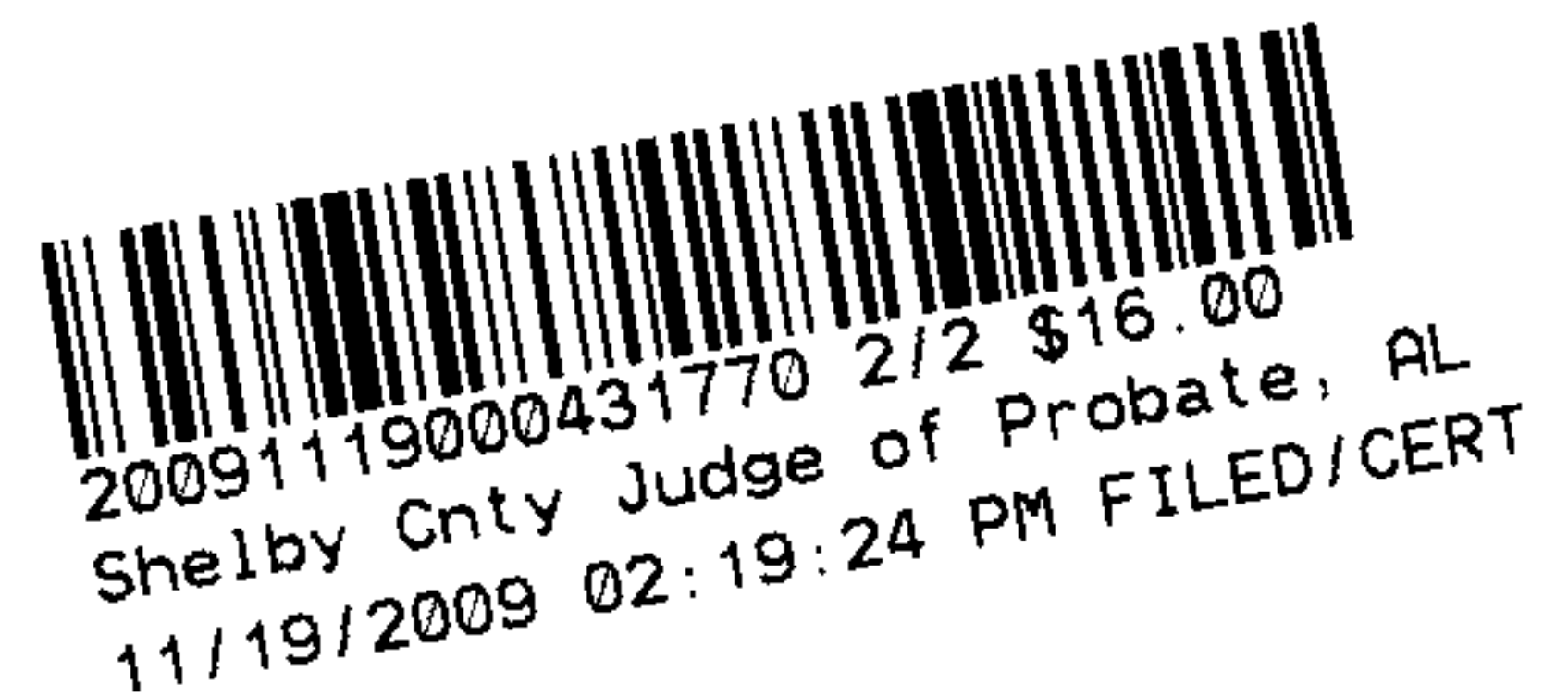
