Being natural persons over the age of twenty-one (21) years, for the purpose of forming a non-profit corporation pursuant to the provisions of the "Alabama Non-Profit Corporation Act", Act No. 578, approved September 12, 1955, General Acts, 1955, Page 1254, do hereby certify as follows:

**ARTICLE I**  
**NAME**

The name of the Corporation is: Bama Black Widows Softball, Inc.

**ARTICLE II**  
**DURATION**

The period of duration of the corporation shall be perpetual; and the corporate existence will commence on the filing of these articles.

**ARTICLE III**  
**PURPOSE**

The purpose or purposes for which the Corporation is organized are: The promotion of the game of softball among young girls involved in the Bama Black Widows Softball League.

**ARTICLE VII**  
**BY-LAWS**

The Board of Directors may adopt by-laws for the governance of the Corporation.

**ARTICLE VIII**  
**REGISTERED OFFICE AND AGENT**

The address of the initial registered agent of the Corporation is 240 Davis Road, Wilsonville, Alabama 35186 and the name of its initial registered agent at such address is Chris Clark.

**ARTICLE IX**  
**AUTHORITY**

Said Corporation is organized on a nonstick basis. Said Corporation is to be financed under the following general plan: by contributions to it of funds and property absolutely or in any of them, any property real, personal or mixed, without limitations as to amount or value, except such limitations, if any, as may be imposed by law; to sell, convey, and dispose of any such property and to deal with such limitations, if any, may be contained in the instrument under which such property is received; and to exercise any, all and every power for which a nonprofit corporation organized under the provisions of the Alabama Nonprofit Corporation Act, all for the public welfare can be authorized to exercise, but not for any other power. No part of the activities of this corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation.
