KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 19th day of May, 2008, James Brian Chafin aka James B. Chafin and Cindy Womble Chafin aka Cindy W. Chafin, husband and wife, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., solely as nominee for MortgageAmerica, Inc., Corporation, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument#20080528000215540, said mortgage having subsequently been transferred and assigned to CitiMortgage, Inc., ("Transferee"); and

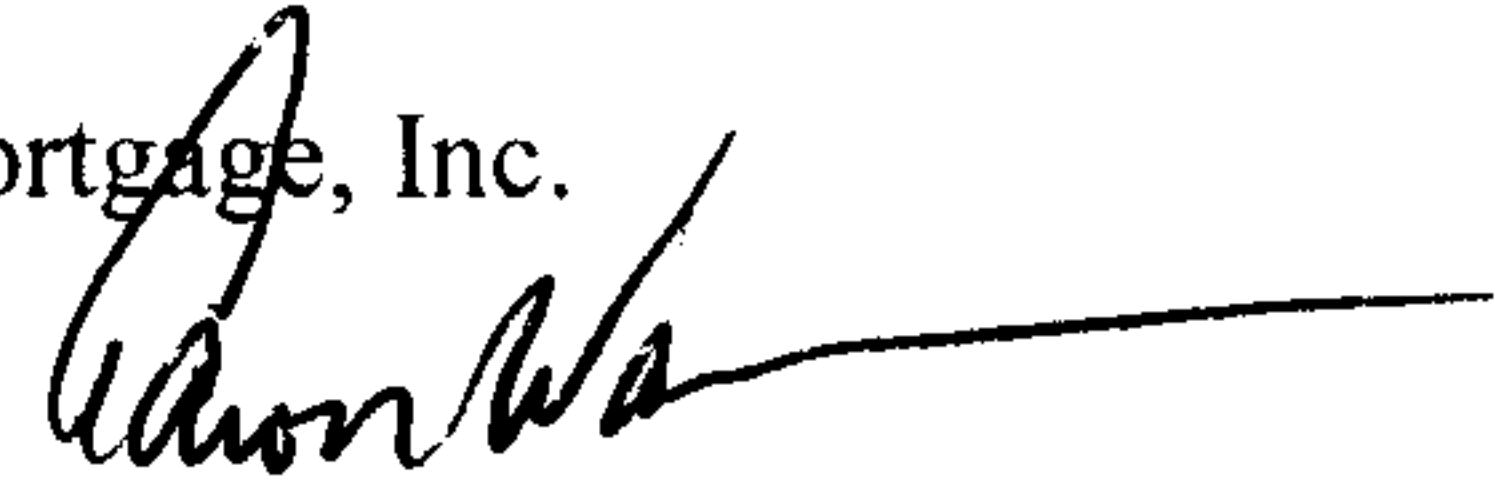

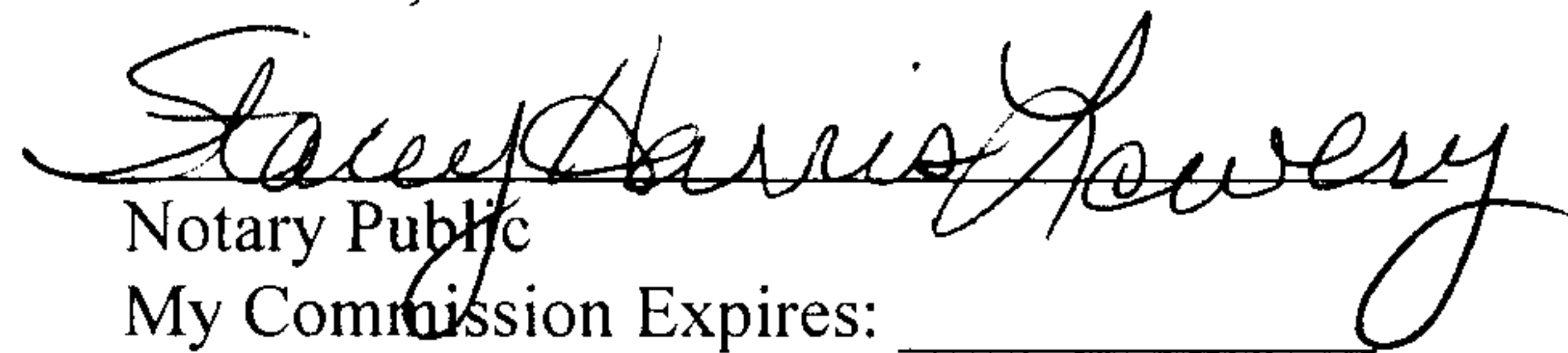
