JOSEPH M. BECK AND RACHEL C. BECK, TRUSTEES, OR THEIR SUCCESSORS IN TRUST, UNDER THE BECK LIVING TRUST, DATED NOVEMBER 20, 2009 AND ANY AMENDMENTS THERETO

(herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby County, Alabama, to-wit:

JOSEPH BECK AND JOSEPH M. BECK ARE ONE AND THE SAME PERSON.


TO HAVE AND TO HOLD to the said grantee, his, her or their successors and assigns forever.

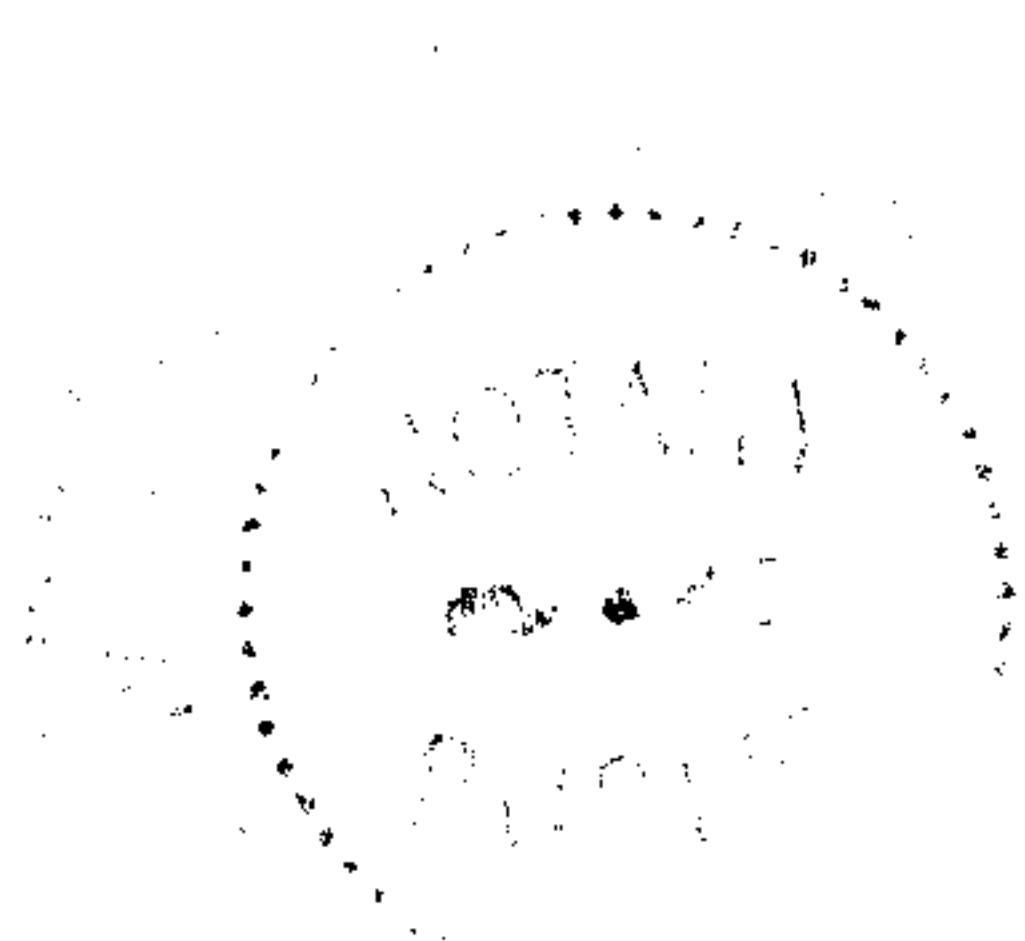


