The undersigned, LYNN EASTMAN, does hereby affirm that my aunt, DELENE SHORT, is one and the same person as DELENA SHORT and DELENE WHITE and was the sole surviving grantee of the following deeds:

DELENE WHITE was the surviving Grantee in that certain deed recorded in Deed Book 229, Page 749. The other grantee, LYNN WHITE, having died on or about February 10, 1968. As to the southerly portion of the land only, title was vested in DELENA SHORT and OLAN SHORT by survivorship deed recorded in Deed Book 275, Page 811. DELENA SHORT was the surviving Grantee in that certain deed recorded in Deed Book 275, Page 811. The other grantee, OLAN SHORT, having died on or about September 9, 2003. This affidavit being necessary to establish that OLAN SHORT was deceased prior to December 8th, 2005, at which time DELENA SHORT executed a deed to LYNAL D. CHAPPELL, which was recorded in Instrument No. 20051209000638330 as "an unmarried woman" in the Office of the Judge of Probate of Shelby County, Alabama; said property being further described as follows:



Legal Description



Parcel A:

A part of the SW ¼ of SE ¼ of Section 28, Township 19 South, Range 1 East, Shelby County, Alabama, and being more particularly described as follows:

From the Southwest corner of the Southwest ¼ of the Southeast ¼ of Section 28, Township 19 South, Range 1 East, also being the Point of Beginning; run Northerly along the West line of said ¼- ¼ a distance of 263.29 feet; thence right 115 deg. 03 min. 58 sec. a distance of 335.33 feet to the North right-of-way of Shelby County Highway Number 55; thence right to the tangent of a curve to the left having a radius of 2,487.65 feet and a delta of 3 deg. 27 min. 27 sec. along the right-of-way of said road arc distance of 150.12 feet; thence right from the tangent of said curve 53 deg. 52 min. 07 sec. leaving said right-of-way a distance of 212.70 feet to the Point of Beginning.

Parcel B:

A part of the SW ¼ of SE ¼ of Section 28, Township 19 South, Range 1 East, Shelby County, Alabama, and being more particularly described as follows:

From the Southwest corner of the Southwest ¼ of the Southeast ¼ of Section 28, Township 19 South, Range 1 East, run Northerly along the West line of said ¼- ¼ a distance of 263.29 feet to the Point of Beginning; thence continue in a straight line a distance of 157.43 feet; thence right 115 deg. 03 min. 58 sec. a distance of 442.16 feet to the North right-of-way of Shelby County Highway Number 55; thence right 107 deg. 25 min. 29 sec. to the tangent of a curve to the left having a radius of 2,487.65 feet and a delta of 3 deg. 24 min. 45 sec. an arc distance along the right-of-way of 148.17 feet; thence right 75 deg. 59 min. 17 sec. from the tangent of said curve leaving said right-of-way a distance of 335.33 feet to the Point of Beginning.

All being situated in Shelby County, Alabama.
