**AMENDED AND RESTATED
ARTICLES OF ORGANIZATION OF
JB, LLC**

Pursuant to the Provisions of Section 10-12-11 of the Code of Alabama (1975), the undersigned members hereby adopt the following **Amended and Restated Articles of Organization of JB, LLC**, organized on the November 14, 2006 and recorded in the records of the Judge of Probate of Shelby County, Alabama as Instrument Number 20061117000562890.

ARTICLE I
Name

The name of the limited liability company is **JB, LLC**, (the "Company").

ARTICLE II
Duration

The Company shall have a duration from the date of organization is perpetual, unless it is dissolved and its affairs wound up prior to that date in accordance with the Alabama Limited Liability Company Act (the "Act").

ARTICLE III
Purposes

The purposes for which the Company is formed are:

- (a) Lease Real Property and Operate a Restaurant and Tavern.
- (b) To render to others, and to engage in the business of rendering to others, consulting, advisory, administrative, industrial engineering, accounting, bookkeeping and other services of every nature, kind, and character, which it may legally render;
- (c) To engage in any industrial, manufacturing, mining, mercantile, trading, agricultural, service, or other lawful business of any kind or character whatsoever;
- (d) To act as agent, representative, or receiver of any person, firm, corporation, or governmental entity or instrumentality in respect to any lawful undertaking or transaction;
- (e) To purchase, take, receive, lease or otherwise acquire, own, hold, improve, use, and otherwise deal in or with, real or personal property, or any interest therein, wherever situated, and to sell, convey, mortgage, pledge, lease, exchange, transfer and otherwise dispose of real or personal property, or any interest therein;
- (f) To purchase, take, receive, subscribe for, or otherwise acquire, own, hold, vote, use, employ, sell, mortgage, lend, pledge, or otherwise dispose of, and otherwise use and deal in and with, shares or other interests in, or obligations of, corporations, limited liability companies, associations,

partnerships, individuals, or direct or indirect obligations of governmental entities or of any instrumentality thereof;

(g) To lend money, invest and reinvest its funds, and take and hold real and personal property as security for the payment of funds so loaned or invested; and

(h) To engage in any other lawful act or activity for which limited liability companies may be organized pursuant to the Act.

ARTICLE IV *Registered Office; Registered Agent*

The location and street address of the initial registered office of the Company shall be and its registered agent at such address shall be **Craig H. Beegle, 109-B Canyon Park, Pelham, AL 35124**

ARTICLE V *Members*


