**LIMITED POWER OF ATTORNEY**

U.S. Bank National Association ("U.S. Bank"), a national banking association organized and existing under the laws of the United States of America, 60 Livingston Ave. 3<sup>rd</sup> Floor, St Paul, MN 55107 hereby constitutes and appoints Ocwen Loan Servicing I.I.C. and in its name, aforesaid Attorney-In-Fact if such documents are required or permitted under the terms of the "Agreements" listed on the attached Exhibit A, by and through any officers appointed by the Board of Directors of Ocwen Loan Servicing I.I.C., to execute and acknowledge in writing or by facsimile stamp all documents customarily and reasonably necessary and appropriate for the tasks described in items (1) through (4) below; provided however, that the documents described below may only be executed and delivered by such Attorneys-In-Fact if such documents are required or permitted under the terms of the related servicing agreements and no power is granted hereunder to take any action that would be adverse to the interests of the Trustee or the Holders. 3 Execute bonds, notes, mortgages, deeds of trust and other contracts, agreements (including subordination agreements) and instruments regarding the Borrowers and/or the Property, including but not limited to the execution of releases, satisfactions, assignments, and other instruments pertaining to mortgages or deeds of trust, and execution of deeds and associated instruments, if any, conveying the Property, in the interest of U.S. Bank National Association.

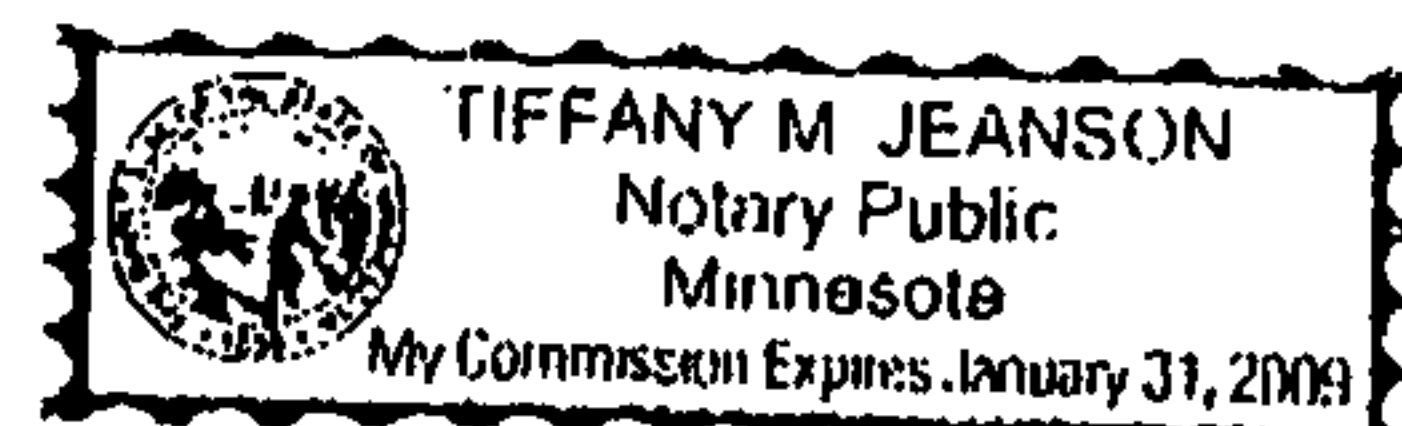

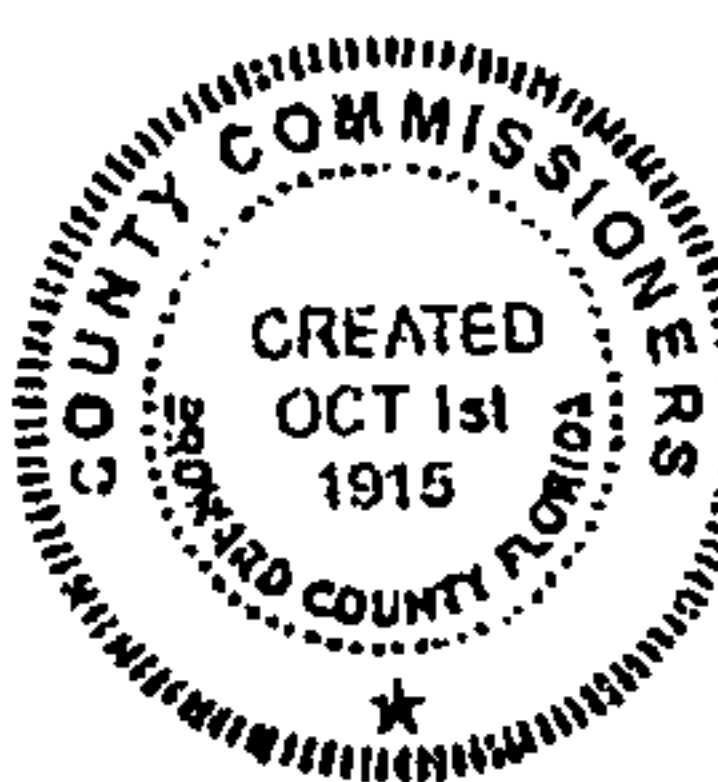
