KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration of One Hundred Seventy-Two Thousand Five Hundred and 00/100 (\$172,500.00) DOLLARS, and other good and valuable consideration, this day in hand paid to the undersigned GRANTORS, Charles A. Daugherty, Jr. and Teri C. Daugherty, husband and wife (hereinafter referred to as GRANTORS), the receipt whereof is hereby acknowledged, the GRANTORS do hereby give, grant, bargain, sell and convey unto the GRANTEES, Robert E. Portera and Jean S. Portera, husband and wife, (hereinafter referred to as GRANTEES), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described Real Estate, lying and being in the County of SHELBY, State of Alabama, to-wit:

Lot 35, according to the Survey of Weatherly, Glen Abbey, Sector 12, as recorded in Map Book 18, page 128 in the Probate Office of Shelby County, Alabama. Mineral and mining rights excepted.

\$138,000.00 of the above-recited purchase price was paid from a mortgage loan closed simultaneously herewith.
