KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 21st day of December, 2004, Bao D. Han, an unmarried man, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc as nominee for Cendent Mortgage Corporation, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument No. 20050110000013250, said mortgage having subsequently been transferred and assigned to PHH Mortgage Corporation, ("Transferee"); and
