
#### MORTGAGE MODIFICATION AGREEMENT

This Mortgage Modification Agreement is made and entered into on the 7<sup>th</sup> day of December, 2009 by and between <u>JAMES HOWARD STONE AND WIFE, MARGARET A. STONE</u>, (hereinafter called "Mortgagor") and <u>BAPTIST HOSPITAL CREDIT UNION</u>, (hereinafter called "Mortgagee").

- A. Mortgagor entered into original Mortgage Agreement with Mortgagee on September
   2, 2009 as recorded in Instrument No. 20090909000345850 on September 9, 2009 in
   the Probate Office of Shelby County, Alabama.
- B. Party desires to amend the terms of said Mortgage and the Note executed simultaneously therewith.

These things considered, Mortgagee hereby allows Mortgagors to increase the amount of the debt secured by above described mortgage from \$75,000.00 to \$100,000.00, an increase of \$25,000.00.

Further, the <u>monthly payment</u> shall be increased from <u>\$645.15</u> to <u>\$862.27</u> commencing January 20, 2010, and the <u>maturity date</u> of the Mortgage and Note shall be extended from <u>September 20</u>, <u>2024</u>, to <u>October 20, 2024</u>. The Mortgagor has paid the interest current to December 20, 2009; therefore, no monthly payment shall be due from Mortgagor on December 20, 2009.


