ARTICLE IV



The amendment, consistent with the Limited Liability Company Act, was approved by a majority vote of the members entitled to vote or in accordance with the

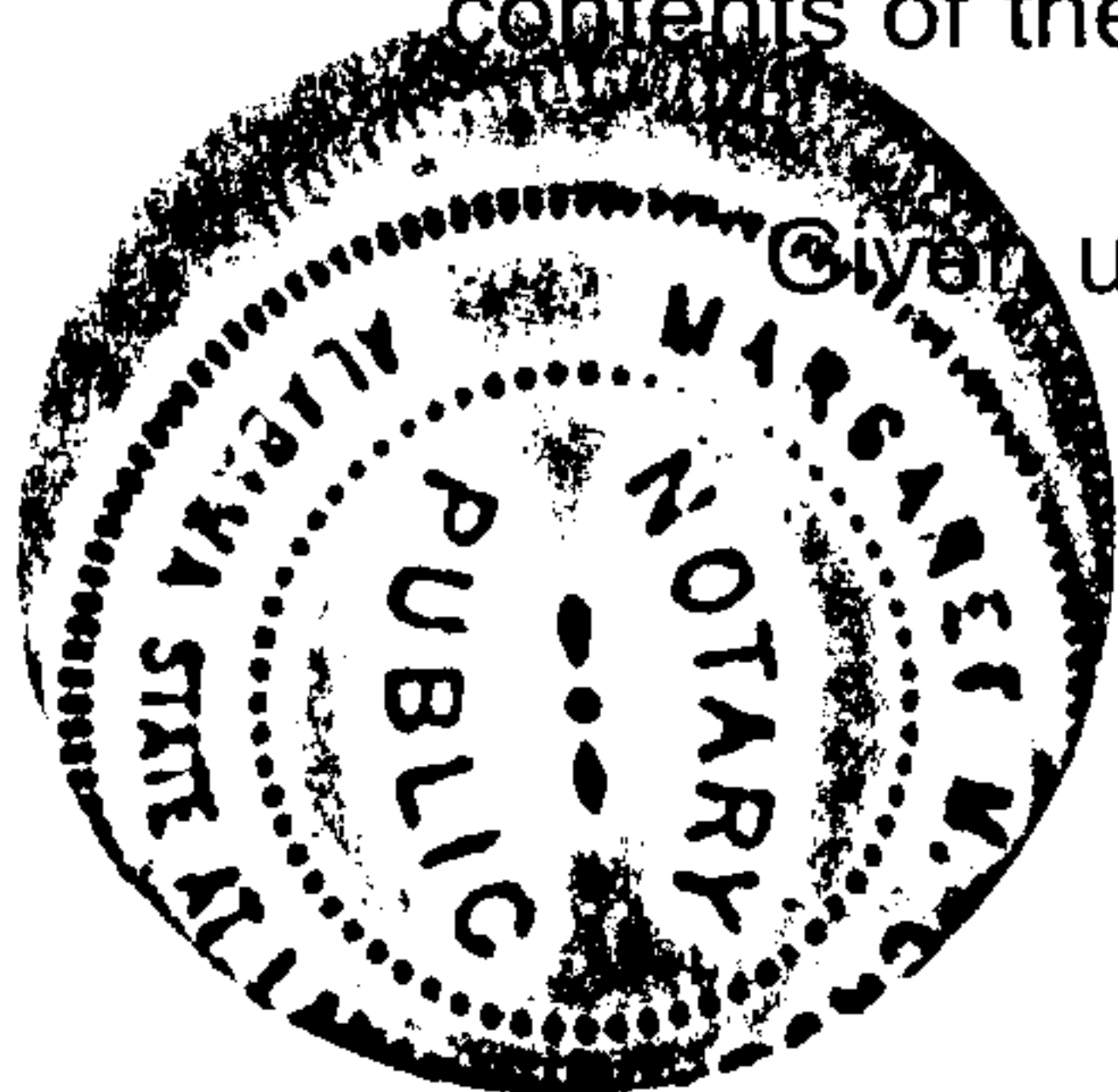
requirements set forth in the articles of organization and prescribed by law.



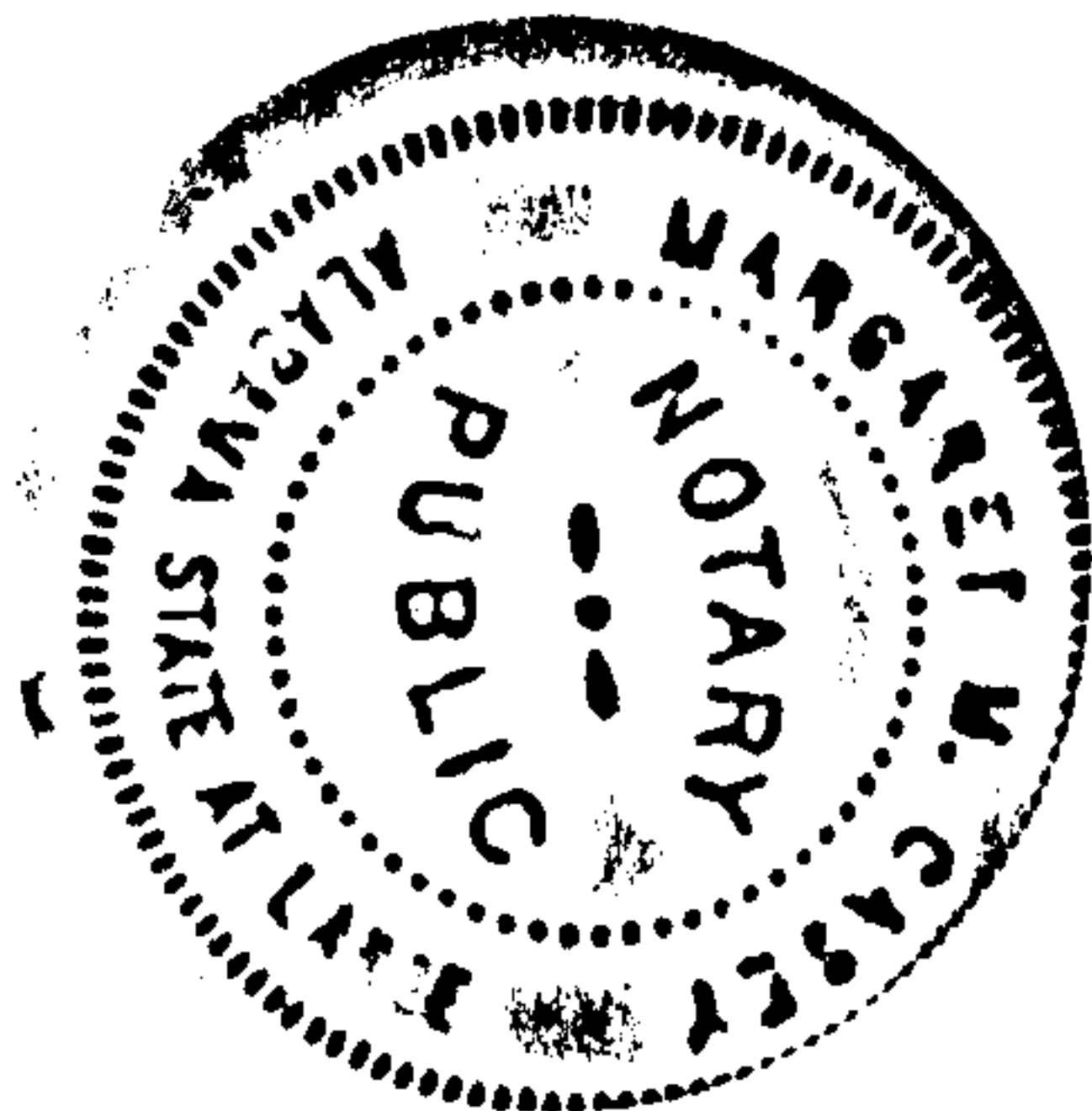
