KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 30th day of July, 2003, Ronnie McCoy and Krissy McCoy, husband and wife, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., solely as nominee for Hometown Mortgage Services, Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Inst. # 20030806000511580, said mortgage having subsequently been transferred and assigned to Chase Home Finance LLC, ("Transferee"); and

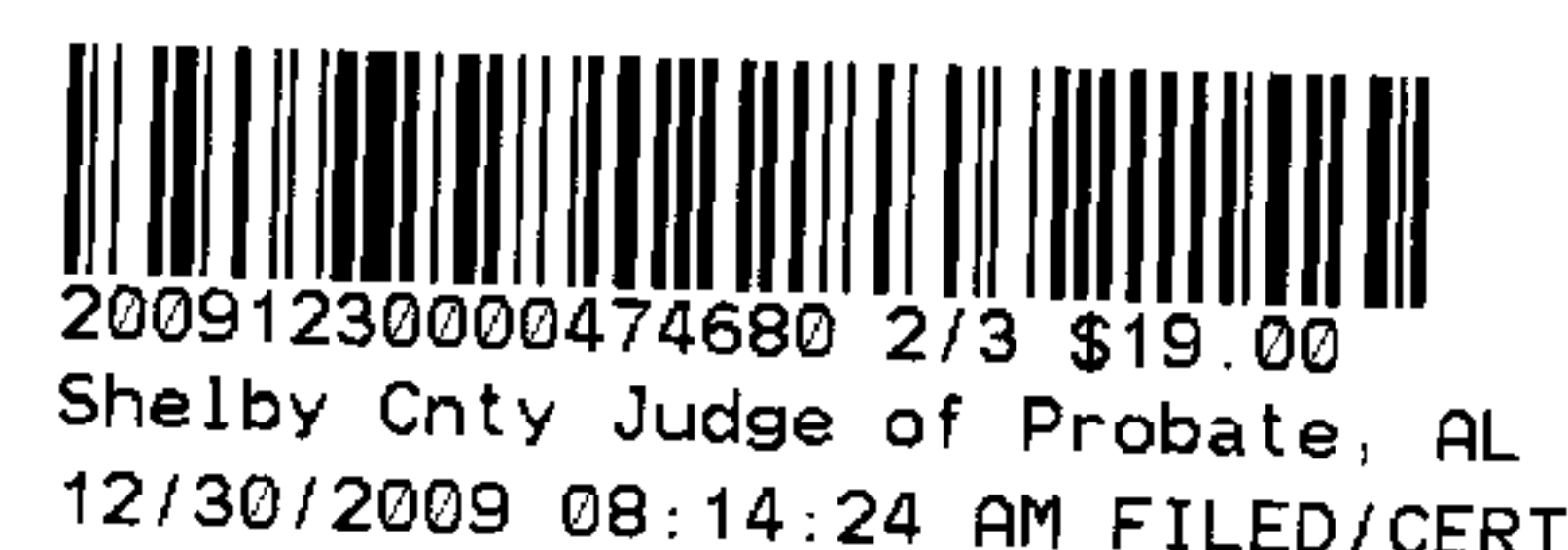


