WHEREAS, Wilma G. Scott (the "Deceased") died January 24, 2009, in Chilton County, Alabama; and

WHEREAS, the Deceased died possessed of certain real property located in Shelby County, Alabama, by Quit Claim Deed with Right of Survivorship with Ellis Gentry, recorded in the Office of the Probate Judge of Shelby County, Alabama as Instrument Number 1998-08882; and
