

ARTICLES OF ORGANIZATION

MADDALENA EQUESTRIAN SOLUTIONS, LLC

PURSUANT TO THE ALABAMA LIMITED LIABILITY COMPANY ACT,
THE UNDERSIGNED HEREBY ADOPTS THE FOLLOWING ARTICLES OF
ORGANIZATION.

ARTICLE I NAME

The name of the Limited Liability Company is Maddalena Equestrian
Solutions, LLC. (the "LLC").

ARTICLE II DURATION

The duration of the LLC is perpetual.

ARTICLE III PURPOSES

The LLC has been organized for the following purposes:

- 1) To train horses for a fee payable by the horse's owner or other individual;
- 2) To train and coach any rider or other individual for a fee;
- 3) To provide consignment or fees services for the purpose of marketing,
promotion and sale and/or purchase of any horse;
- 4) To show horses for any owner, coach, rider, or other individual for a fee;
- 5) To board horses and/or provide boarding, feeding, stabling, grooming or
other services for the maintenance of horses for a fee;
- 6) To own, lease, board, maintain, feed, stable or otherwise maintain horses
owned in the name of the LLC or any member of the LLC;
- 7) To sell, lease, show, promote, market or otherwise provide services for
horses owned in the name of the LLC or any member of the LLC;
- 8) To provide any service whatsoever related to any equestrian sports and/or
the maintenance of horses not specifically delineated herein;
- 9) To lease or own real property;
- 10) To open, use and/or maintain checking, savings, or other financial
accounts as necessary;
- 11) To conduct business pursuant to any other valid, legal purpose allowed
under the laws of the State of Alabama.

**ARTICLE IV
REGISTERED ADDRESS AND AGENT**

The registered office of the LLC shall be 25115 Portobello Road, Birmingham, AL 35242. The name of the registered agent for service for the LLC shall be Yvonne Norris Beshany, c/o Jackson Lewis LLP, 800 Shades Creek Parkway, Birmingham, AL 35209.

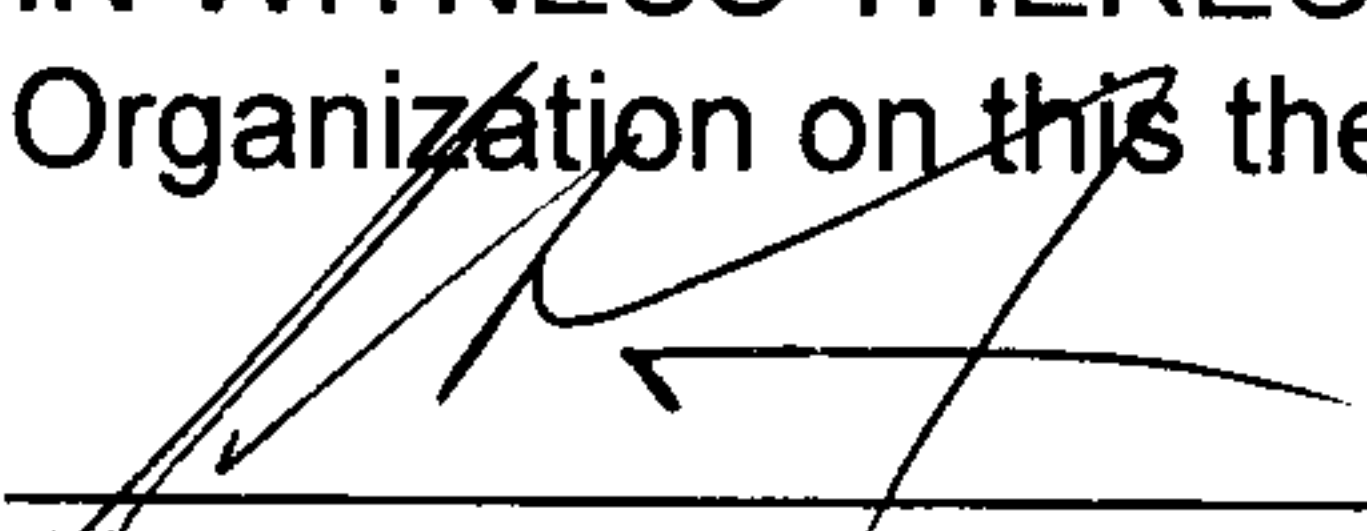

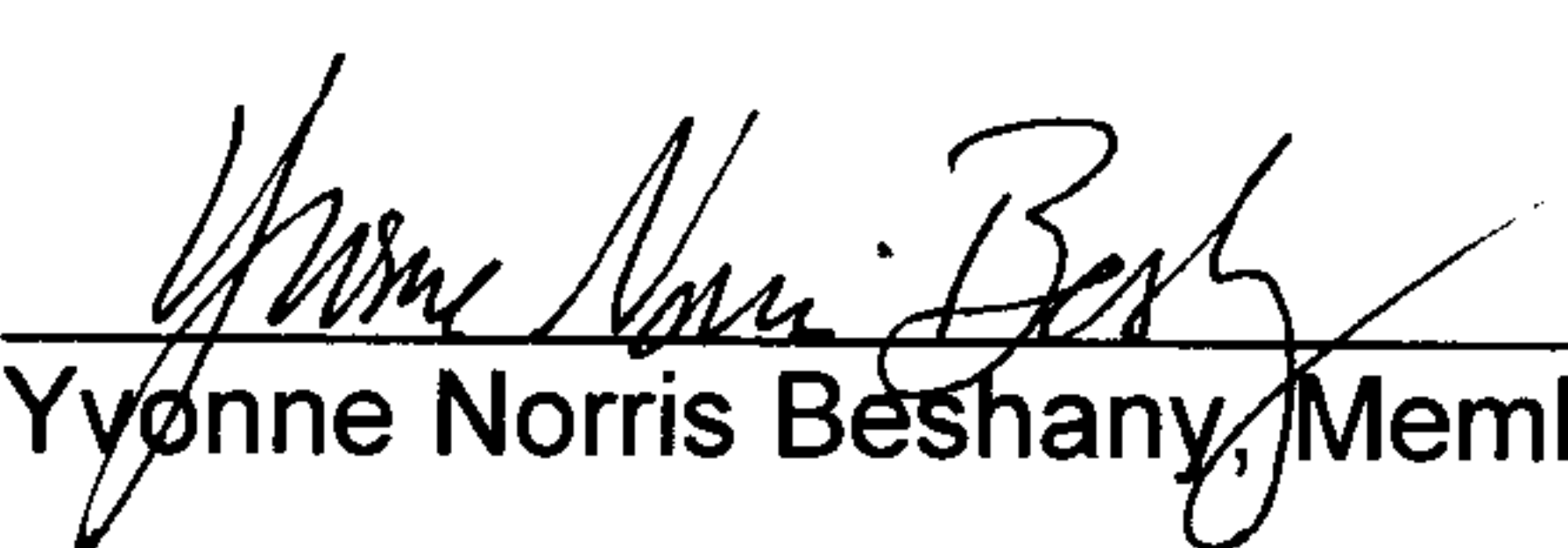
