## **AMENDMENT**

## TO

## REAL ESTATE MORTGAGE

THIS AMENDMENT amends is by and among THORNTON NEW HOME SALES, INC. and THORNTON CONSTRUCTION COMPANY, INC. and amends that certain Real Estate Mortgage (hereinafter "Mortgage") executed on July 9, 2009 in favor of BANCORPSOUTH (also known as BANCORPSOUTH BANK) (hereinafter "Bank").
