TO THE HONORABLE JUDGE OF PROBATE
OF SHELBY COUNTY, ALABAMA:

The undersigned, for the purpose of forming a limited liability company (the "Company") pursuant to the provisions of the Alabama Limited Liability Company Act (the "Act") (Alabama Code §10-12-1, et seq.) hereby certifies as follows:

1. NAME OF COMPANY. The name of the Company is:

" SLDRM, LLC "

2. COMPANY OPERATING AGREEMENT. The affairs and business of the Company and the relations of its Members are regulated and established under and subject to the terms and conditions of the Operating Agreement of the Company executed by and among all of the initial Members, as the same may be amended from time to time in accordance with its terms (the "Operating Agreement"). The Operating Agreement is hereby incorporated by reference as a part of these Articles of Organization.

3. PERIOD OF DURATION. The period of duration of the Company shall be perpetual, provided that the Company shall be dissolved and its affairs shall be wound up upon the occurrence of any event of dissolution specified in the Operating Agreement.

4. COMPANY PURPOSES. The Company has been organized for the purpose of managing capital for the Members and specifically for the purposes set out in the Operating Agreement. The Company may also transact any other lawful business for which a limited liability company may be formed under the Act, but nothing contained herein shall be construed as authorizing the Company to carry on the business of banking or insurance or to act as a trust company, securities broker, securities dealer or investment advisor.

5. INITIAL REGISTERED OFFICE AND INITIAL REGISTERED AGENT. The location and mailing address of the initial registered office of the Company are:


