

THE ARTICLES OF ORGANIZATION OF BUZZ & CUTS, LLC

Pursuant to the Provisions of CODE OF ALABAMA § 10-12-1 et seq. (1975), known as the "Alabama Limited Liability Company Act," the undersigned hereby adopt the following Limited Liability Company Articles of Organization.

ARTICLE I

Name of Limited Liability Company

The name of the limited liability company shall be BUZZ & CUTS, LLC (the "Company").

ARTICLE II


Period of Duration

The Company shall have a perpetual duration from the date of organization until the end of time, unless it is dissolved and its affairs are wound up prior to that date in accordance with the Alabama Limited Liability Company Act (the "Act").

ARTICLE III

Statement of Purpose

The purpose for which the Company is formed is to engage in any lawful act or activity for which limited liabilities companies may be organized pursuant to the Act.



ARTICLE IV

Registered Office and Registered Agent

ARTICLE V

Initial Member and Organizer

The initial member shall also be the organizer. The name and address of the initial member and organizer is:

ARTICLE VI

Member Management

The Company shall be managed by its members who have been identified in Article V as the initial members/organizers.

ARTICLE VII

Admission of Additional Members

Upon the unanimous written consent of the members, the Company may permit the admission of additional members, and the terms and conditions of their admission shall be set forth in the Company's Operating Agreement.
