**STATUTORY WARRANTY DEED**

**KNOW ALL MEN BY THESE PRESENTS**, that in consideration of One Hundred Thirty Five Thousand and no/100 Dollars (\$135,000.00) to the undersigned **Thornton New Home Sales, Inc.**, an Alabama corporation (“Grantor”), in hand paid by **LaToya N. Stewart** (“Grantee”), the receipt and sufficiency of which are hereby acknowledged, the said Grantor does by these presents, grant, bargain, sell and convey unto Grantee, the following described real estate, situated in Shelby County, Alabama, to-wit:

Lot 17 according to the Final Plat of Holland Lakes, Sector Two, Phase One, as recorded in Map Book 36, Page 8, in the Probate Office of Shelby County, Alabama; being situated in Shelby County, Alabama (the “Property”).

**TOGETHER WITH** the nonexclusive easement to use the Common Areas as more particularly described in the Holland Place Declaration of Covenants, Conditions and Restrictions recorded as Instrument # 20050426000199570 in the Probate Office of Shelby County, Alabama, as amended by the First Amendment thereto recorded as Instrument # 20070312000109060 in said Probate Office, and as may be further amended from time to time (which, together with all amendments thereto, is hereinafter collectively referred to as the “Declaration” which is incorporated herein by reference in its entirety).

Note: \$132,554.00 of this purchase price is being paid by the proceeds of a first mortgage loan executed and recorded simultaneously herewith.

**Title is vested in Thornton New Home Sales, Inc., as survivor in its merger with Holland Lakes, Inc.**

Note: \$4,050.00 of this purchase price is being paid by the proceeds of a second mortgage recorded simultaneously herewith.

The Property is conveyed subject to the following:

- (1) Ad valorem taxes due and payable October 1, 2010 and all subsequent years thereafter;
- (2) Mineral and mining rights not owned by Grantor;
- (3)Municipal improvements, assessments and fire district dues against subject property, if any;
- (4) The easements, restrictions, assessments, covenants, agreements and all other terms and provisions of the Declaration and in Map Book 36 page 8 as recorded in said Probate Office; and
- (5) All easements, restrictions, reservations, agreements, rights-of-way, building setback lines and any other matters of record.


Grantee, by acceptance of this deed, acknowledges, covenants and agrees for itself and for its successors and assigns, that Grantor shall not be liable for and Grantee hereby waives, releases and forever discharges Grantor, its officers, agents, employees, directors, shareholders, partners, contractors, subcontractors, mortgagees and each of their respective successors and assigns, for any and all liability claims and causes of action of any nature on account of loss, damage, or injuries to buildings, structures, improvements, personal property or to Grantee or any owner, occupants or other person who enters upon any portion of the Property as a result of or arising out of any past, present or future soil, surface and/or subsurface conditions, known or unknown, (including without

limitation, radon, sinkholes, underground mines, tunnels and limestone formations and deposits) under or upon the Property or any property surrounding, adjacent to or in close proximity with the Property.

**TO HAVE AND TO HOLD** unto the said Grantee, her successors and assigns forever.


