WHEREAS, heretofore, on, to-wit: the 28th day of June, 2007, Joel R. Harned and Mary E. 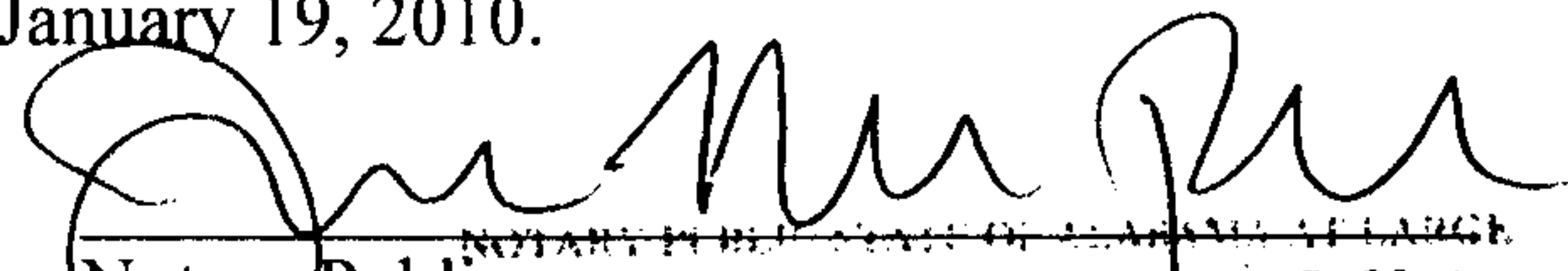
