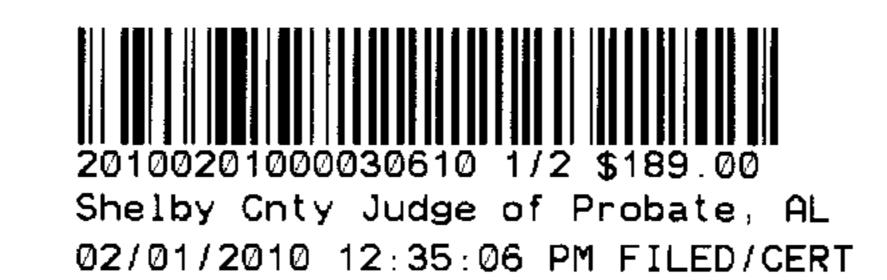

WARRANTY DEED WITH RIGHT OF SURVIVORSHIP

KNOW ALL PERSONS BY THESE PRESENTS, that for and in consideration of the sum of One Hundred Seventy Five Thousand and 00/100 Dollars (\$175,000.00), paid to the undersigned grantors, James L. Simmons and wife, Betty G. Simmons, (herein referred to as GRANTORS) in hand paid by the grantees herein, the receipt and sufficiency of which is hereby acknowledged by said GRANTORS, do by these presents, GRANT, BARGAIN, SELL AND CONVEY to Virginia B. Cornelius and Carol J. Cornelius, (herein referred to as GRANTEES) for and during their joint lives and upon the death of either of them, then to the survivor in fee simple, together with every contingent remainder and right of reversion, the following described real estate, situated in Shelby County, Alabama, to-wit:

Lot 15, Block 3, according to the Survey of Mission Hills, Second Sector, as recorded in Map Book 6, Page 114 in the Probate Office of Shelby County, Alabama; being situated in Shelby County, Alabama.

This conveyance is subject to all easements, covenants, rights-of-way and restrictions of record, and taxes for 2010 and subsequent years.
