I, Paul E. Petersen, residing at 60 Deer Creek Road, Pittsford, New York 14534, as the sole beneficiary of the Family Trust created under Article VIII of the First Amendment and Restatement of the Tamea L. Petersen Revocable Trust dated June 9, 2008, do hereby irrevocably renounce, reject, forever disclaim and refuse to accept any and all interest as life beneficiary of the Family Trust created under Article VIII of the First Amendment and Restatement of the Tamea L. Petersen Revocable Trust dated June 9, 2008.

This renunciation and disclaimer is made with the understanding and expectation that it is irrevocable and will be treated as a qualified disclaimer under §2518 of the Federal Internal Revenue Code and an effective renunciation under §2-1.11 of the New York Estate, Powers and Trusts Law, so that such property which is includible in the remainder of the Tamea L. Petersen Revocable Trust shall be distributed as if I had predeceased **Tamea L. Petersen**, the decedent herein, and that after the payment of cash legacies to the decedent's grandchildren under Article VII, the remainder shall pass in accordance with Article X "Distribution on Death of Survivor" of the Tamea L. Petersen Revocable Trust.
