WHEREAS, said Lease, as amended, was ratified by **Kimberly-Clark Worldwide, Inc.,** a Delaware corporation, in that certain Ratification of Coalbed Methane Gas Lease, as filed in the Office of the Probate Judge of Bibb County, Alabama in Real Property Book 190, at page 186, and in the Office of the Probate Judge of Shelby County, Alabama as Document No. 20070410000163750, to which reference is here made for all purposes; and

WHEREAS, said Lease was amended by a Second Amendment to Coalbed Methane Gas Lease, filed as Memorandum of Second Amendment to Coalbed Methane Gas Lease in the Office of the Probate Judge of Bibb County, Alabama in Real Property Book 198, at Page 262, and in the Office of the Probate Judge of Shelby County, Alabama as Document No. 20070808000370360, to which reference is here made for all purposes; and

WHEREAS, effective July 1, 2009, CDX Gas, LLC, et al, assigned all its right, title and interest in said Lease to Calera Gas, LLC at RPB 234, Page 93 of the probate records of Bibb County, Alabama, and as Document No. 20090724000285890 of the probate records of Shelby

County, Alabama; and

WHEREAS, the parties have executed a Third Amendment to Coalbed Methane Lease dated November 2, 2009 amending Articles 2, 3.9 and 7.2 of the original Coalbed Methane Lease dated November 29, 2004; and

WHEREAS, the parties now desire to recognize that said Coalbed Methane Gas Lease was amended on November 2, 2009 by amending certain language in Article 2, Article 3.9 and Article 7.2 of above referenced Lease.

NOW, THEREFORE, KNOW ALL MEN BY THESE PRESENTS, the Lessor and Lessee, for and in consideration of the mutual benefits to be derived by the parties hereto, do hereby acknowledge and recognize that certain language was amended in Article 2, Article 3.9 and Article 7.2 of the above referenced unrecorded Lease.
