

PARTIAL RELEASE OF COALBED METHANE GAS LEASE

STATE OF ALABAMA

COUNTIES OF BIBB AND SHELBY

WHEREAS, Bowater Alabama, Inc., an Alabama corporation (referred to herein as "Lessor") and CDX Sequoya, LLC, a Texas limited liability company (referred to herein as "Lessee") entered into a COALBED METHANE GAS LEASE ("Said Lease") dated October 12, 2004 (the "Effective Date") wherein Lessee leased certain interests from Lessor in Bibb and Shelby Counties, Alabama, which Said Lease is evidenced by Memorandum of Coalbed Methane Gas Lease as filed in the Office of the Judge of Probate of Bibb County, Alabama in RPB 148, page 500 and in the Office of the Judge of Shelby County, Alabama as Document No. 20050303000100960, to which reference is here made for all purposes; and

WHEREAS, Part of said Lease was assigned to W. Ray Wallace by Assignment dated September 28, 2005, as filed in the Office of Judge of Probate of Bibb County, Alabama in RPB 161, at page 410, and in the Office of the Judge of Probate of Shelby County, Alabama as Document No. 20051028000562400, to which reference is here made for all purposes; and

WHEREAS, said Lease was amended by a First Amendment to Coalbed Methane Gas Lease, which is evidenced by Memorandum of First Amendment to Coalbed Methane Gas Lease as filed in the Office of the Judge of Probate of Bibb County, Alabama in RPB 223, at Page 737, and in the Office of the Judge of Probate of Shelby County, Alabama as Document No. 20070420000185010, to which reference is here made for all purposes; and

WHEREAS, said Lease was amended by a Second Amendment to Coalbed Methane Gas Lease, which is evidenced by Memorandum of Second Amendment to Coalbed Methane Gas Lease as filed in the Office of the Judge of Probate of Bibb County, Alabama in RPB 193, at Page 783, and in the Office of the Judge of Probate of Shelby County, Alabama as Document No. 20070521000234610, to which reference is here made for all purposes; and

WHEREAS, said Lease was amended by a Third Amendment to Coalbed Methane Gas Lease, which is evidenced by Memorandum of Third Amendment to Coalbed Methane Gas Lease as filed in the Office of the Judge of Probate of Bibb County, Alabama in RPB 223, at Page 640, and in the Office of the Judge of Probate of Shelby County, Alabama as Document No. 20081121000446590, to which reference is here made for all purposes; and

WHEREAS, CDX Sequoya, LLC, et al, assigned all its right, title and interest in said Lease to Calera Gas, LLC by Assignment, Bill of Sale and Assumption Agreement dated July 1, 2009, as filed in RPB 234, Page 93 of the probate records of Bibb County, Alabama, and at Instrument Number 20090724000285890 of the probate records of Shelby County, Alabama; and

WHEREAS, W. Ray Wallace assigned all his right, title and interest in said Lease to Calera Gas, LLC by Assignment, Bill of Sale and Assumption Agreement dated July 1, 2009, as filed in RPB 235, Page 406 of the probate records of Bibb County, Alabama, and at Instrument Number 20090909000345540 of the probate records of Shelby County, Alabama; and

WHEREAS, Said Lease, as amended, provides that at any time and from time to time, Lessee shall have the right to release from the terms of Said Lease any and all of the Leased Premises.

NOW, THEREFORE, know all men by these presents, Calera Gas, LLC does hereby release, relinquish and surrender all of their right, title and interest in certain lands covered by said Lease, these lands more specifically described on Exhibit "A" attached hereto, which is adopted and incorporated herein.

Undersigned parties acknowledge that in all other respects, Said Lease, as amended, shall remain unchanged and shall remain in full force and effect and subject to all terms and provisions contained therein.


