Lee became, seized in fee simple of certain real property situated in Shelby County, Alabama, more particularly described, as follows:

Lots 1 and 3, Block 4, Thomas Addition to the Town of Aldrich, as recorded in Map Book 3, Page 52, Probate Office, Shelby County, Alabama, being situated in Shelby County, Alabama; also, Lot 1, Block 5, within said Subdivision.

- 3. On or about June 23, 1960, Perry N. Lee and wife, Beatrice McAllister Lee conveyed said Lot 1, Block 5, of said Subdivision, pursuant to Deed recorded at Deed Book 210, Page 384, in the Office of the Probate Judge, Shelby County, Alabama; thereby, retaining all right, title and interest in and to Lots 1 and 3, Block 4 of said Subdivision.
- 4. Said Perry N.
