This is a **MILITARY POWER OF ATTORNEY** prepared pursuant to Title 10, United States Code, Section 1044b and executed by a person authorized to receive legal assistance from the military services. Federal law exempts this power of attorney from any requirement of form, substance, formality, or recording that is prescribed for powers of attorney under the law of a State, the District of Columbia, or a territory, Commonwealth, or possession of the United States. Federal law specifies that this power of attorney shall be given the same legal effect as a power of attorney prepared and executed in accordance with the laws of the jurisdiction where it is presented.

KNOW ALL MEN BY THESE PRESENTS

That I, Brian Keith Shirley, a legal resident of the State of Alabama, have made, constituted, and appointed, and by these presents do make, constitute, and appoint Kristen Nicole Shirley as my true and lawful attorney-in-fact, giving and granting to my attorney-in-fact full authority and power to:

1. **PROPERTY:** Lease, sell, insure, transfer, mortgage, pledge, exchange, or otherwise dispose or encumber any and all of my property, be it real, personal, or mixed, in which I now or hereafter may have an interest, and to execute and deliver good and sufficient title, deed, or other instrument for the lease, conveyance, mortgage, or transfer of my property. Eject, remove, or relieve tenants or other persons from and recover possession of any property, be it real, personal, or mixed, in which I now or hereafter may have an interest. Buy, receive, lease, accept, or otherwise acquire in my name and for my account property, be it real, personal, or mixed, upon such terms, considerations, and conditions as my attorney-in-fact shall deem proper.
2. **COLLECTION OF DEBTS:** Collect, sue for, compromise, or otherwise dispose of any claim, debt, rents, or share in an estate in which I now or hereafter may have an interest.
3. **BANKING TRANSACTIONS:** Deposit in my name and for my account with any bank, banker, credit union, savings and loan association, or any other financial institution all funds, checks, drafts, bills of exchange, promissory notes, and other securities which may come into the hands of my attorney-in-fact in such capacity, including, but not limited to, **FEDERAL and STATE INCOME TAX REFUND CHECKS**, instruments drawn on the United States, Treasury or other fiscal officer or depository of the United States, or of a State, Commonwealth, Territory, or Possession of the United States, or any political subdivision thereof; and, for that purpose, to sign my name in the manner provided below to endorse any instrument. Withdraw any and all funds on deposit with any bank, banker, credit union, savings and loan association, or any other financial institution that has funds belonging to me on deposit and to draw checks, drafts, or other orders for funds thereon in my name in the manner provided below. Close accounts and receive funds on deposit therein. Receive statements, notices, or other documents from any bank, banker, credit union, savings and loan association, or any other financial institution concerning any and all accounts or banking transactions in my name or in which I have an interest. Endorse, cash, and receive proceeds of any and all checks, drafts, vouchers, or other orders for funds. I expressly **WITHHOLD** the power to open new banking accounts, including, but not limited to, savings, checking, loan and credit card accounts, or other accounts in my name, and I further **WITHHOLD** the power to increase or exceed credit limits on existing credit, credit card, signature loan, or other similar accounts.
4. **SAFE DEPOSIT BOXES:** Have access for all purposes to any and all safe deposit boxes or vaults rented in my name or in the names of any person or persons and myself as joint owners, with full power to use same for safekeeping of any of my property or any of my papers and to remove therefrom at any time or from time to time all or any part of the contents of same.
5. **LOANS:** Borrow money in my name from Army Emergency Relief (AER) or American Red Cross, and only from those sources, when deemed necessary by my attorney-in-fact, upon such terms as my attorney-in-fact shall deem proper, and to execute such instruments as may be required for such purpose. I expressly **WITHHOLD** the power to obtain any other loan, to execute any installment sales contract, or to use any credit, credit card, signature loan, or other similar account.
6. **TAX RETURNS:** Prepare, execute, sign in the manner provided below, and file Federal, State, and Local income and other tax returns.
7. **SHIPMENT AND RECEIPT OF PROPERTY:** Receive and take possession and order removal and shipment of any property, including but not limited to household goods, unaccompanied (hold) baggage, and motor vehicles, from and to any post, warehouse, depot, dock, or other place of storage or safekeeping whether controlled by the government or private concern, and to execute and deliver any release, voucher, receipt, shipping ticket, certificate, or other instrument necessary or convenient for such purpose.
8. **MOTOR VEHICLES AND WATERCRAFT:** Execute and deliver to the proper person and authority any and all documents instruments, and papers necessary to register, sell, insure, or transfer title of any such motor vehicle or watercraft in which I now or may hereafter have an interest and to collect and receive all funds or other consideration paid for such sale and transfer.
9. **BALFOUR BEATTY COMMUNITIES:** To do any and all acts necessary and appropriate with the DFAS Office to establish and/or start an allotment to be sent to: Balfour Beatty Communities at Ft. Stewart and Hunter Army Airfield, Georgia, for an amount equal to BAH. To sign, seal, and execute any and all documents, including the DD Form 2558 (Authorization to Start, Stop, or Change an Allotment) and file with DFAS. To rent, lease, accept, acquire property suitable for living for a fixed period of time upon such terms, considerations, and conditions as my said attorney-in-fact. In the event of damage to said property to initiate, maintain compromise or otherwise dispose of any legal or equitable suit or claim against the other party causing the damage for the loss.
10. **FINANCE:** Obtain from any military finance officer or from my unit my Leave and Earnings Statement (LES), or copies or computer printouts thereof, and receive any military paycheck under the procedures prescribed by the disbursing Finance and Accounting Office.

11. UTILITIES: Connect, commence, disconnect, or terminate utility services including, but not limited to, electricity, gas, water, sewage, garbage collection, local telephone, long distance telephone, and cable television, which are to be or are currently provided to my principal place of residence, and to receive statements, notices, and bills from the providers of such services.

12. MILITARY IDENTIFICATION CARD: To obtain, sign my name to and verify correct information of a DD Form 1172 for purpose of issuance of an I.D. Card for any dependants I may have, including spouse and children. To make any changes necessary to DEERS in order to successfully obtain Military I.D. Card.

FURTHER, I do authorize my attorney-in-fact to perform every act and thing whatsoever that is necessary or appropriate to accomplish the purposes for which this Power of Attorney is granted, as fully and effectually as I could if I were present; and;

EXCEPT for those powers I have intentionally, knowingly, and intelligently NOT granted by crossing-out and initialing the applicable language, and thereby expressly WITHHELD such power and authorization.

I HEREBY RATIFY all that my attorney-in-fact shall lawfully do or cause to be done by virtue of this document;

PROVIDED, however, that all business transacted hereunder for me or for my account shall be transacted in my name and that all endorsements and instruments executed by my attorney-in-fact for the purpose of carrying out the foregoing powers shall contain my name followed by that of my attorney-in-fact and the designation "attorney-in-fact."

This power of attorney shall remain in full force and effect until my death, the death of my attorney-in-fact, I revoke it, or until

20 July 2011, whichever occurs first.

NOTWITHSTANDING the specified date of expiry written in the previous paragraph, if on that date I should be carried in a military status of "missing" or "missing-in-action" or "prisoner of war," then under the provisions of Title 50 Appendix, United States Code, Section 591a, this Power of Attorney shall automatically continue in full force and effect until I am no longer carried in such status.

PROVIDED, however, that if the foregoing paragraph is crossed-out, than this Power of Attorney shall expire upon the date of the expiry stated above under Title 50 Appendix, United States Code, Section 591b.


