KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 14th day of April, 2006, Annette Whittemore, a single person, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., solely as nominee for Colonial Bank, N.A., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Inst. # 20060419000182680, said mortgage having subsequently been transferred and assigned to Chase Home Finance LLC, ("Transferee"); and *Inst # : 20100212000043050*
