WHEREAS, heretofore, on, to-wit: the 4th day of August, 2005, Mark S. Werner and Kathryn C. 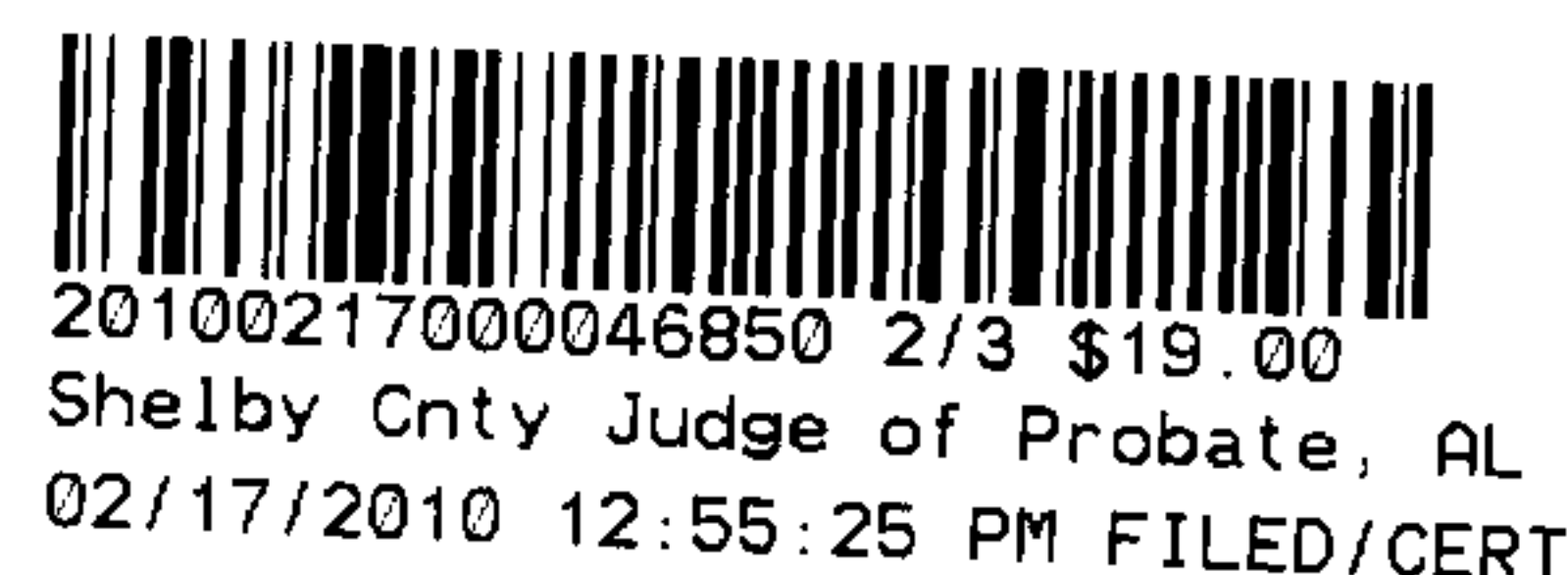




