KNOW ALL MEN BY THESE PRESENTS, That in consideration of the sum of **Fifty Thousand dollars and Zero cents (\$50,000.00)** paid by the grantee herein, the receipt of which is hereby acknowledged, I/we, **David Fowler, a single man**, (hereinafter grantor, whether one or more), do grant, bargain, sell and convey unto **Michael Kortman and Jodene Kortman as joint tenants with rights of survivorship** (hereinafter Grantees), all of my right, title and interest in the following described real estate, situated in **Shelby County, Alabama**:

Lot 35, according to the Survey of River Highlands, as recorded in Map Book 19, Page 111, in the Probate Office of Shelby County, Alabama.
