FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that, whereas, heretofore on, to-wit: the 28th day of February, 2007, DARRIN BRUCE LEDFORD, a single man and TRACY L. WILLIAMS, a single woman, executed a mortgage to SUPERIOR BANK, herein called the Mortgagee, which said mortgage was recorded on March 12, 2007, in Instrument Number 20070312000109790, Probate Records of Shelby County, Alabama, which conveyed the property hereinafter described to secure the indebtedness evidenced by a note, payable in installments, therein described; and
