KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 23rd day of October, 2003, Carl E. Green and Tiffany R. 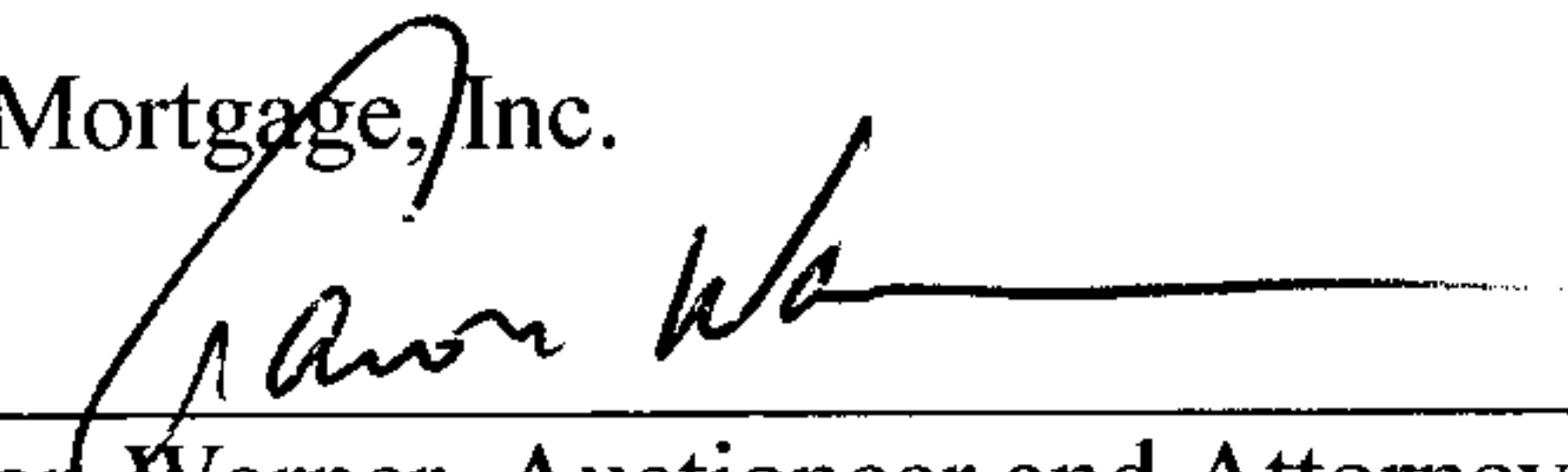

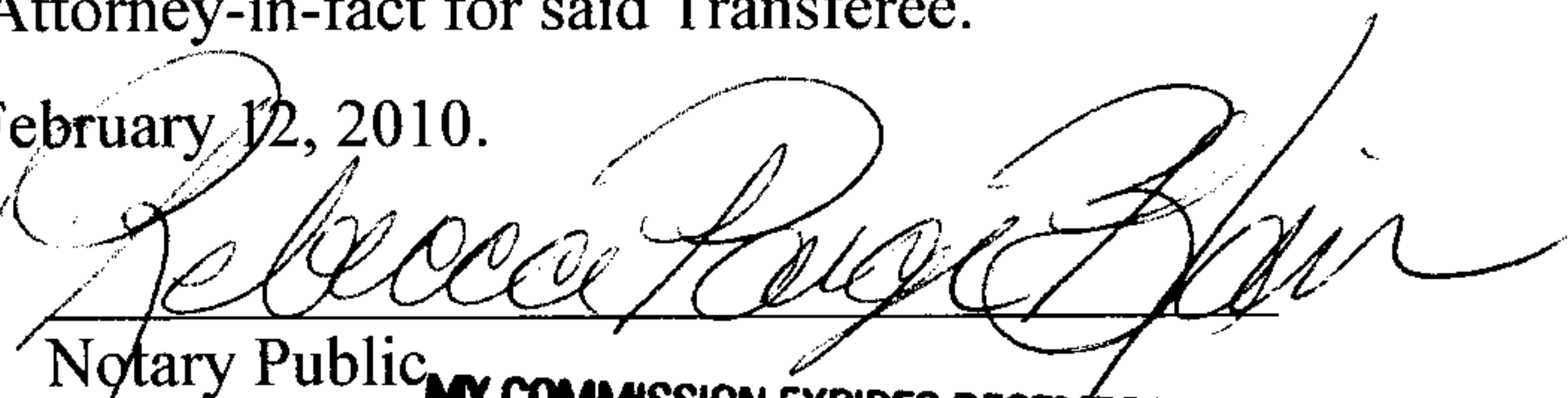
