That said Association claims a lien upon property owned by Tracy Dildy situated in Shelby County, Alabama, described as follows:



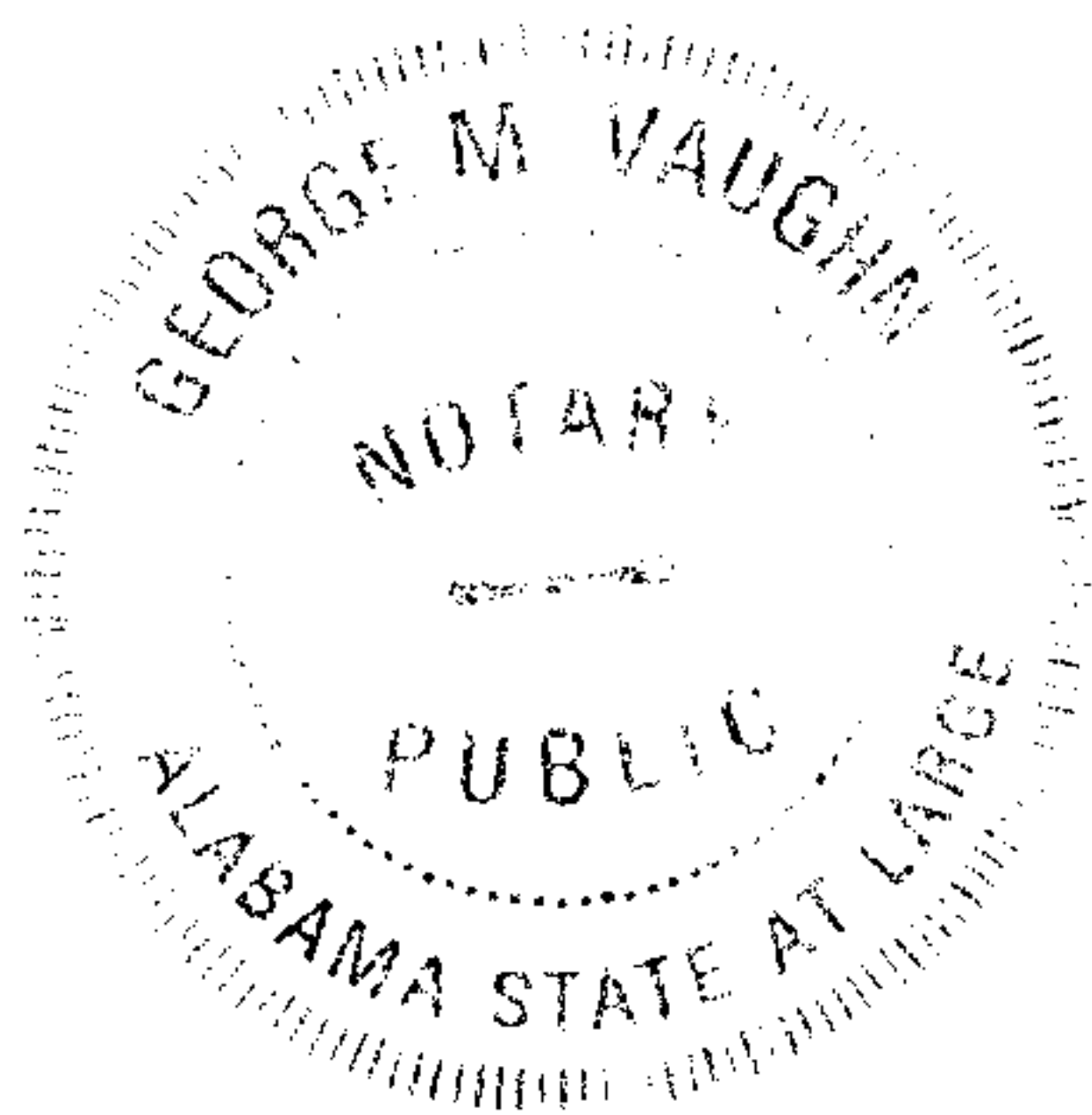
