FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that, whereas, heretofore on, to-wit: the 3rd day of December, 2004, VALERIE YVONNE TAYLOR, married and MICHAEL A. TAYLOR, her husband, executed a mortgage to STATE FARM BANK, F.S.B., herein called the Mortgagee, which said mortgage was recorded on December 9, 2004, in Instrument Number 20041209000673160, Probate Records of Shelby County, Alabama, which conveyed the property hereinafter described to secure the indebtedness evidenced by a note, payable in installments, therein described; and
