

## ARTICLES OF ORGANIZATION

## ANDREW INVESTMENTS L.L.C.

## A LIMITED LIABILITY COMPANY

(Under the provisions of the Alabama Limited Liability Company Act)

- 1. <u>Name.</u> The name of the limited liability company is **ANDREW INVESTMENTS L.L.C.**
- 2. **Purpose.** The purpose of this limited liability company is to transact any or all lawful business for which Limited Liability Companies may be formed and may include the transaction of any and all lawful business for which limited liability companies may be organized in the state of Alabama.
- 3. Address of Office Where Records are Kept. The address to which interested persons may direct requests for copies of any operating agreement and any bylaws of this limited liability company is 1118 Old Cahaba Circle, Helena, Alabama 35080.
- 4. <u>Period of Duration</u>. This LLC shall exist for a period of perpetual duration.

8. Admission of New Members. With the written unanimous consent of the members, new members may be admitted into the LLC upon the payment of such capital contribution and upon such terms as the members unanimously decide. In the event that new members

9. <u>Members Right to Continue Business</u>. The remaining members of the limited liability company shall have the right to continue business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the limited liability company as further set forth in the Operating Agreement of the limited liability company.

Any provision that is not inconsistent with the law for the regulation of the internal affairs of the Limited Liability Company is permitted to be set forth in the operating agreement of the LLC.
