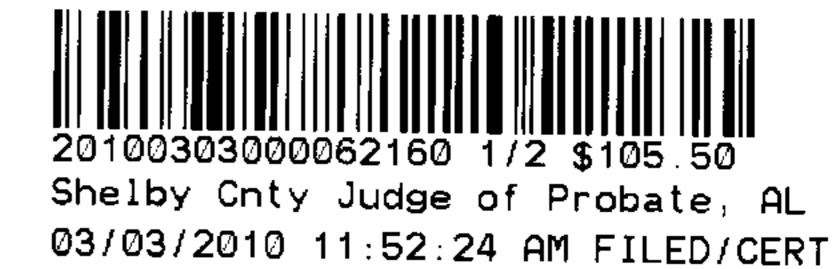
## IN THE PROBATE COURT OF SHELBY COUNTY, ALABAMA
