WHEREAS, heretofore, on, to-wit: the 31st day of August, 2007, Robert S. Sanders and Yocelyn Sanders, husband and wife, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc. acting solely as nominee for A.M. 


