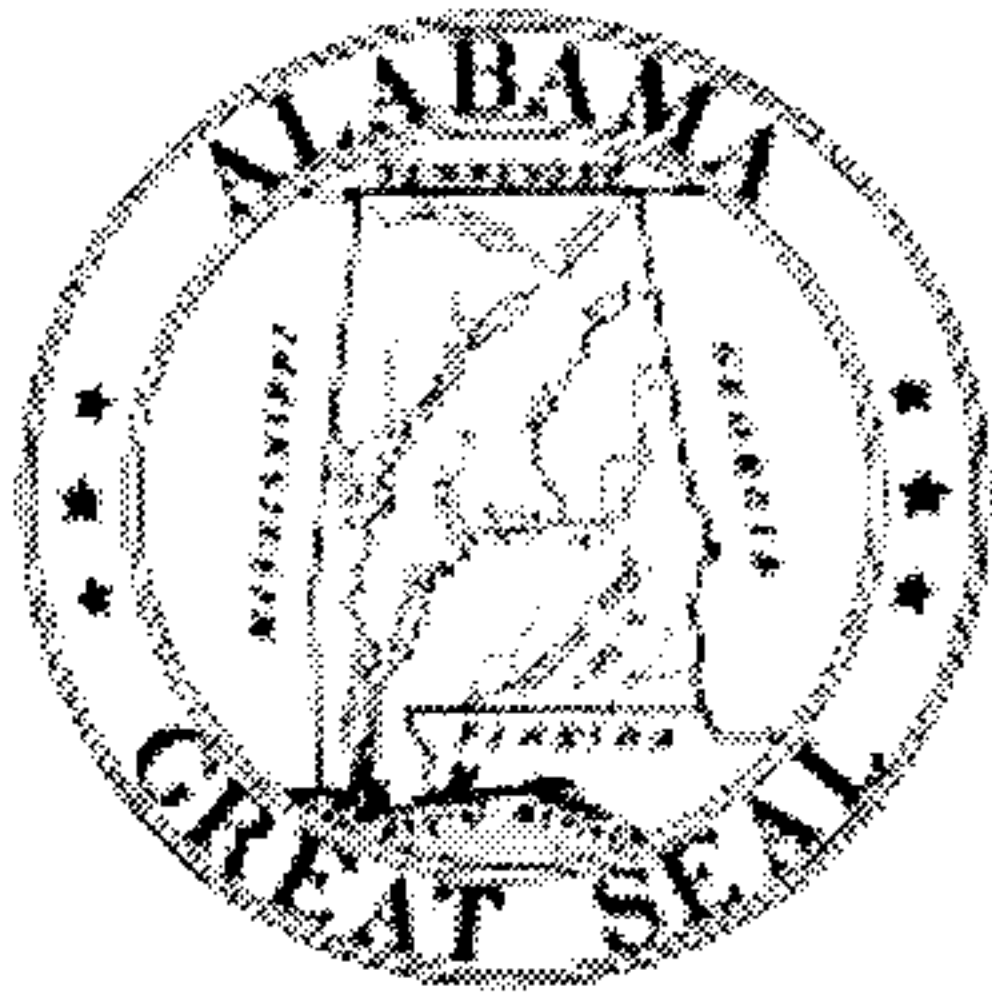




AFFIDAVIT
